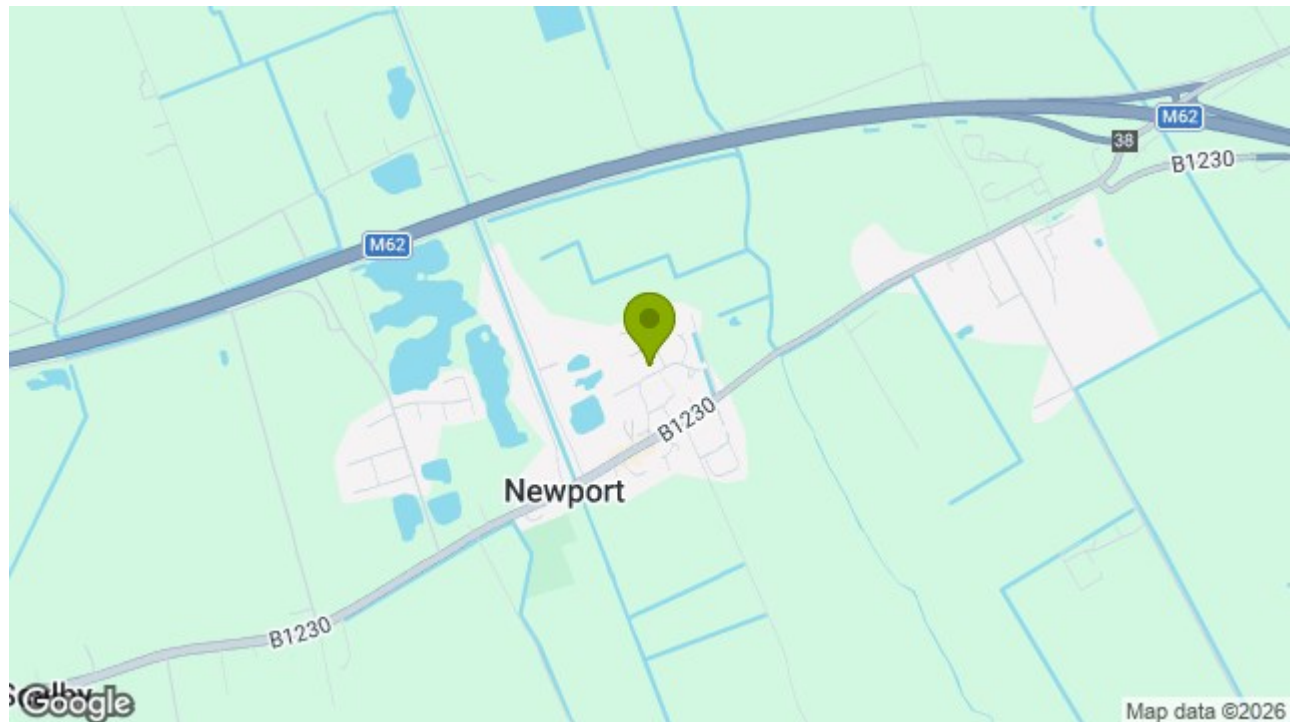
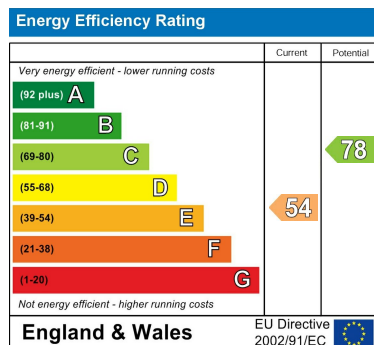

## ACCOMMODATION

The property is arranged over a single storey and comprises:

### GROUND FLOOR

#### ENTRANCE HALL

Allowing access to the property through a residential entrance door. The hallway provides internal access to:

#### LOUNGE

A spacious front facing reception room with ample space for a living room suite. There is a bow window to the front elevation.

#### KITCHEN

The kitchen is fitted with a range of wall and base units which are mounted with contrasting worksurfaces beneath a tiled splashback. A stainless steel sink unit sits beneath a window to the side elevation and there is space for a number of undercounter appliances. A door leads from the side driveway.

#### INNER HALLWAY

With access to the remainder of the accommodation.

#### BEDROOM 1

A double bedroom with fitted wardrobes and a window to the rear elevation.

#### BEDROOM 2

A good sized second bedroom with a window to the rear.

#### SHOWER ROOM

Fitted with a three piece suite comprising WC, pedestal wash basin and a corner shower cubicle with an electric shower. There is tiling to the walls, a built-in cupboard and a window to the side elevation.

### OUTSIDE

#### FRONT

To the front of the property there is a lawned garden with planting beds.

#### REAR

The rear garden is a good size and is mainly laid to lawn. There are planting beds flanking one edge of the lawn and a gravel area and planting beyond.

#### DRIVEWAY & GARAGE

A gravel driveway provides off street parking. The driveway continues through wrought iron gates to the side of the property and beyond to a pre-fabricated garage.

## GENERAL INFORMATION.

SERVICES - Mains water, electricity and drainage are connected to the property.

CENTRAL HEATING - The property has the benefit of a electric storage heaters.

DOUBLE GLAZING - The property has the benefit of PVC double glazed frames.

COUNCIL TAX - From a verbal enquiry/online check we are led to believe that the Council Tax band for this property is Band B. (East Riding Of Yorkshire). We would recommend a purchaser make their own enquiries to verify this.

FIXTURES & FITTINGS - Carpets, curtains & light fittings may be purchased with the property and these will be specified upon inspection but would be subject to separate negotiation.

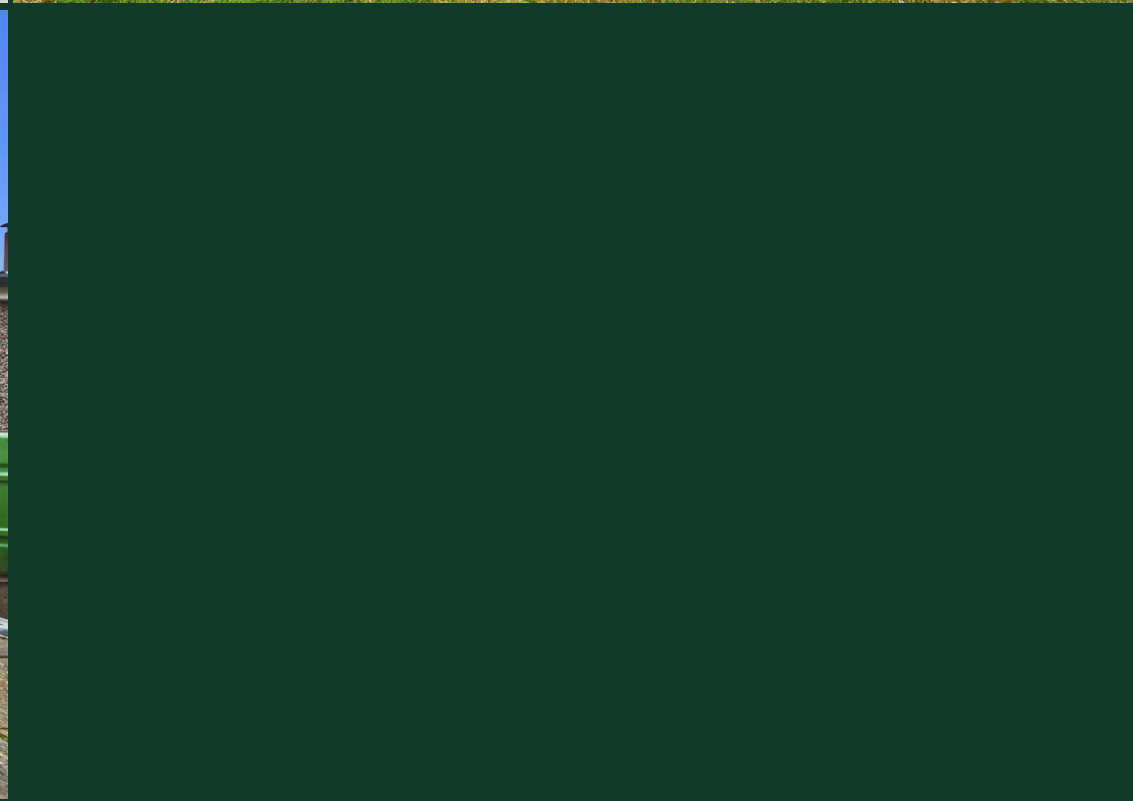

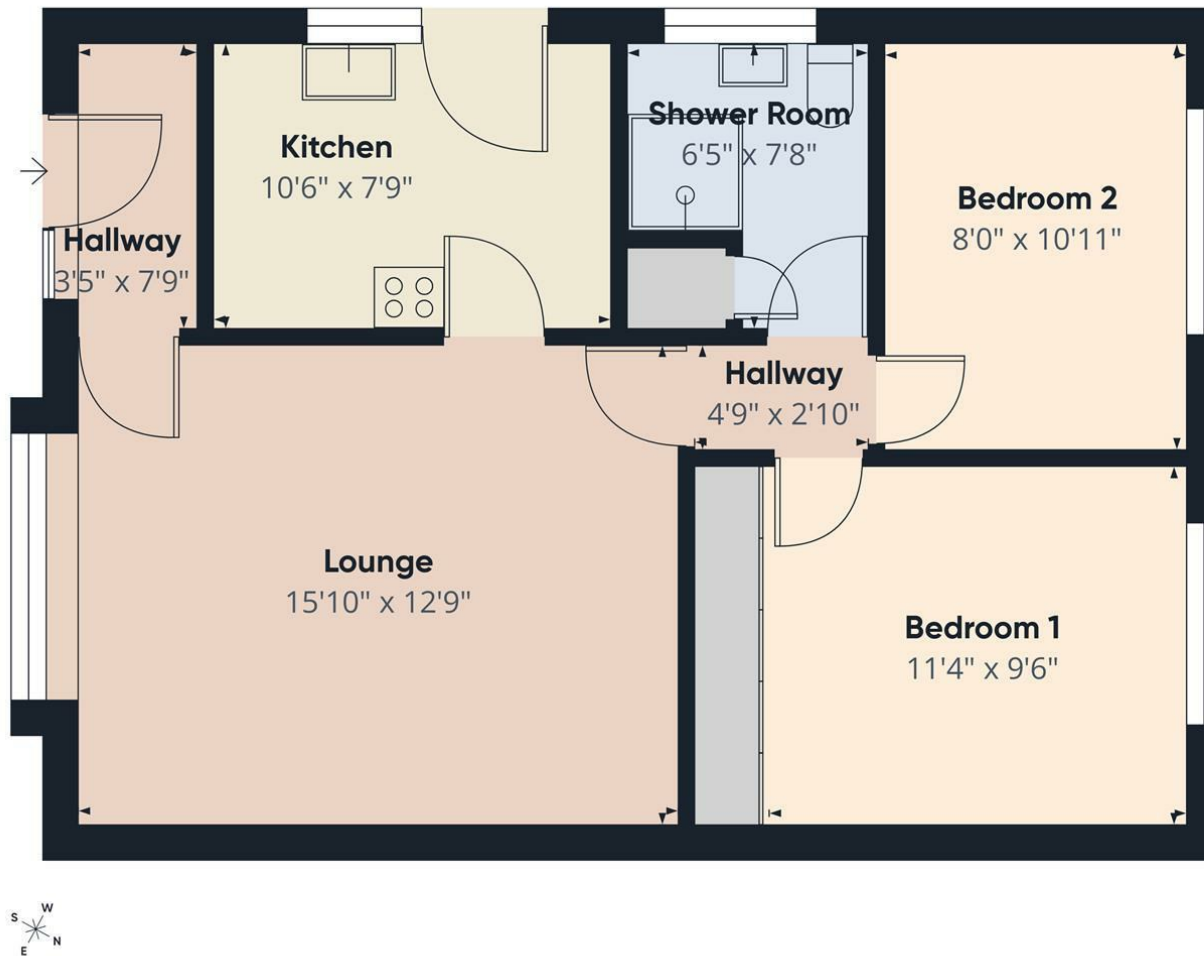
