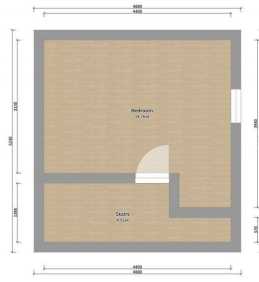

St Stephens Ground Floor



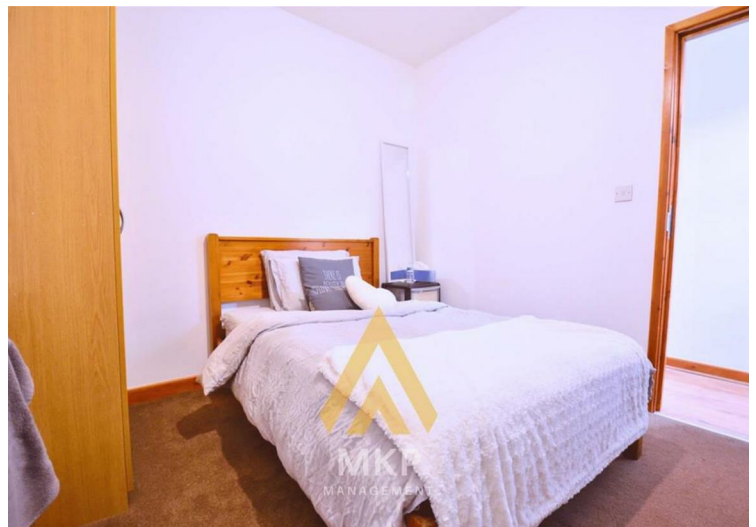
St Stephens First Floor
