The property also has its own sizeable, south-facing, private patio, along with access to a large communal rooftop terrace with beautiful views across London's city skyline.

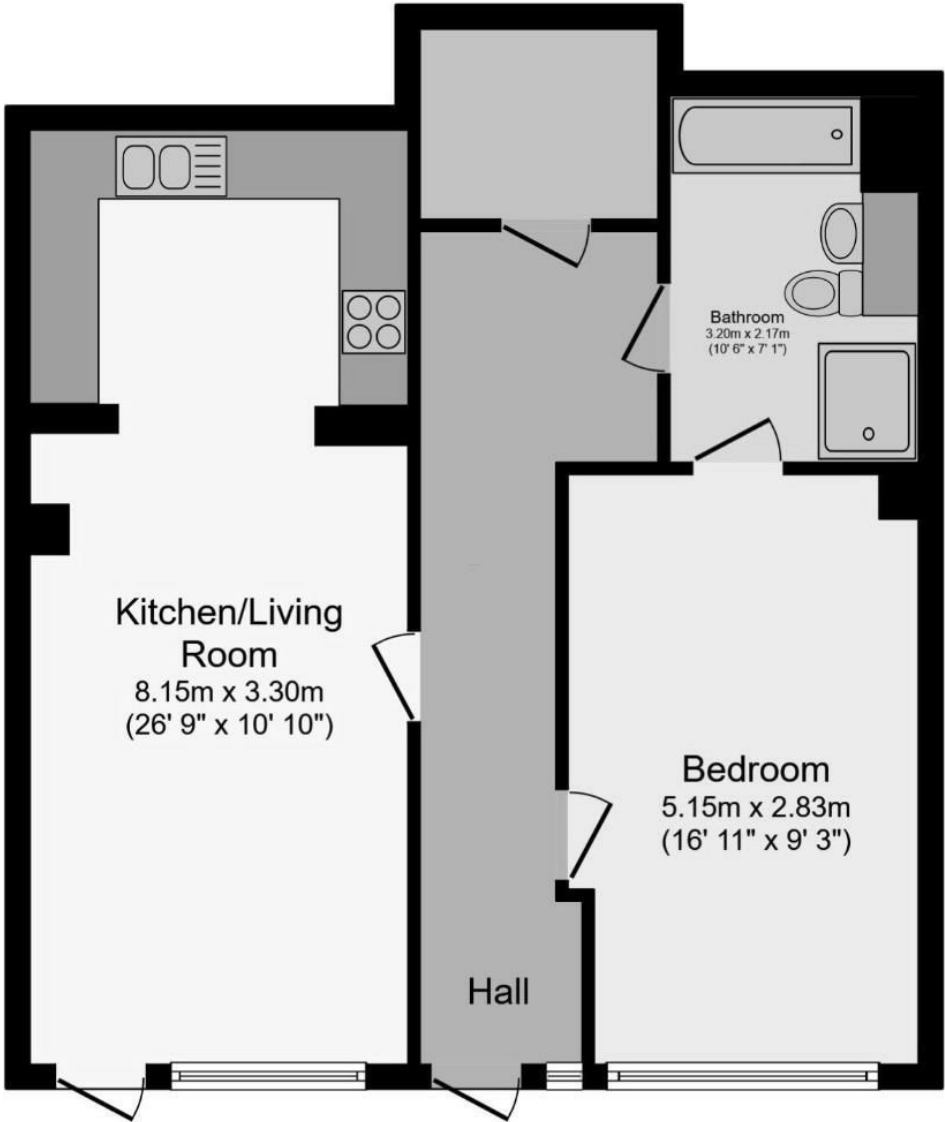
