LOCATION

Letton is a rural hamlet located about 12 miles west of the Cathedral city of Hereford. Neighbouring villages including Eardisley and Staunton-on-Wye combined offer a range of amenities, including primary school and doctor's surgery. Hereford as a whole offers a wide range of shopping, leisure and recreational facilities together with educational establishments. The bordering towns of Hay-on-Wye and Kington are located to the west and north west respectively and offer further amenities.

DESCRIPTION

The subject property is a modern detached house which is presented in good order throughout. The property is double glazed and has the benefit of modern electric heaters on the ground floor and night storage heaters on the first floor. The rooms are well proportioned and the ground floor accommodation is approached via an entrance hall, off which there is a cloakroom, stairway to the first floor, good sized living room and kitchen/breakfast room, utility area, first floor landing with access to four bedrooms, ensuite to the master bedroom and bathroom. On the Bull Farm Cottage development there are just four homes comprising two detached houses and a pair of semis. From the rear of the property, an outlook across glorious Herefordshire countryside to tree lined rising countryside in the far distance. In more detail, the accommodation comprises;

Entrance porch with two pillars and composite door with leaded and double glazed upper panels to the;

With electric radiator, stairs to first floor, laminated flooring and door to the;

Sitting/Dining Room

With front and side aspect double glazed windows, rear aspect double glazed french doors opening to the rear garden, wood burning stove with brick surround, coved ceiling, TV point and wall mounted electric radiator.

With rear aspect double glazed window, a range of units comprising one and a half bowl stainless steel sink drainer unit with work surface, splashback, a range of wall and base mounted units, integrated electric oven and hob with cooker hood over, integrated dishwasher, space for upright fridge/freezer, wall mounted electric radiator, inset spotlights, laminated flooring and door to utility room.

Utility Room

3.1m (10'2) x 1.63m (5'4)

With rear aspect double glazed window, a range of units comprising stainless steel sink drainer unit with work surface, base units under, plumbing and space for washing machine, space for tumble dryer, extractor fan, laminated flooring, door to the garage and garden.



Cloakroom

1.98m (6'6) x 1.07m (3'6)

With low flush WC, wash hand basin with tiled splashbacks, laminated flooring and extractor fan.

With front aspect double glazed window, wall mounted night storage heater and doors to bedrooms and bathroom.

With front aspect double glazed window, night storage heater, coved ceiling and door to ensuite shower room.

With front aspect double glazed window, double shower cubicle with electric shower, low flush WC, pedestal mounted wash hand basin, heated towel rail and partially tiled wall surround.

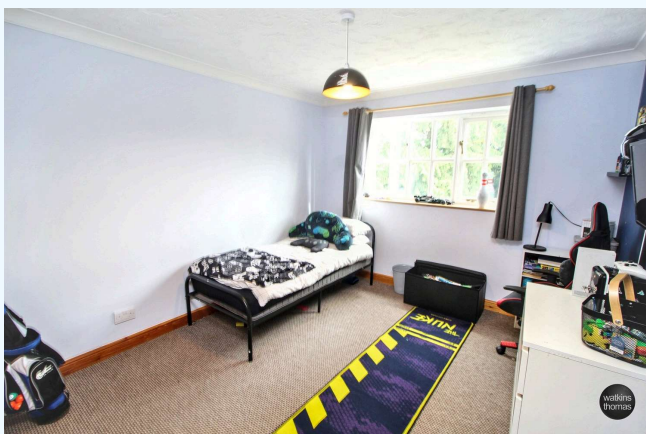
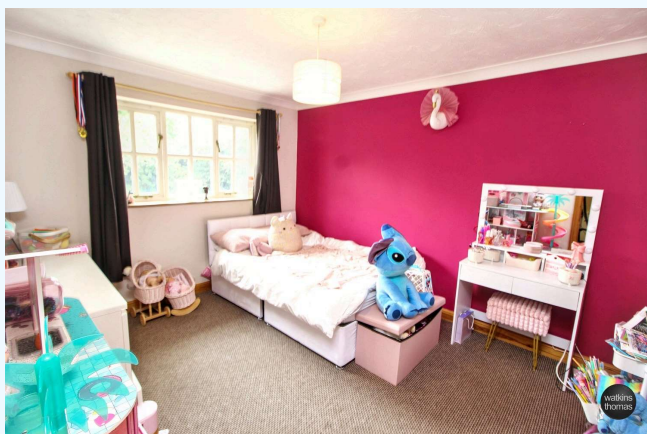

Bedroom 4

With rear aspect double glazed window, night storage heater and coved ceiling.

Bathroom

With rear aspect double glazed window, suite comprising panel enclosed bath with mixer tap and shower attachment, glass shower screen, low flush WC, pedestal mounted wash hand basin, partially tiled wall surround, coved ceiling, night storage heater and vinyl flooring.



OUTSIDE:

A shared entrance area leads to a car parking space, beyond which is an attached garage measuring 17' 6 x 10' 2 and with a ceiling height of 8' 6, with up and over door, power and lighting.

To the front of the property there is a lawned garden area. To the left hand side of the property is a pathway which gives access to the rear garden, where there is a patio area with picket fence and steps leading to the main garden which is laid to lawn. From this area, a fine outlook is enjoyed across agricultural land and rising tree lined countryside in the distance.

At the lower level, there is a further expanse of lawn, a garden storage shed and a decked area.

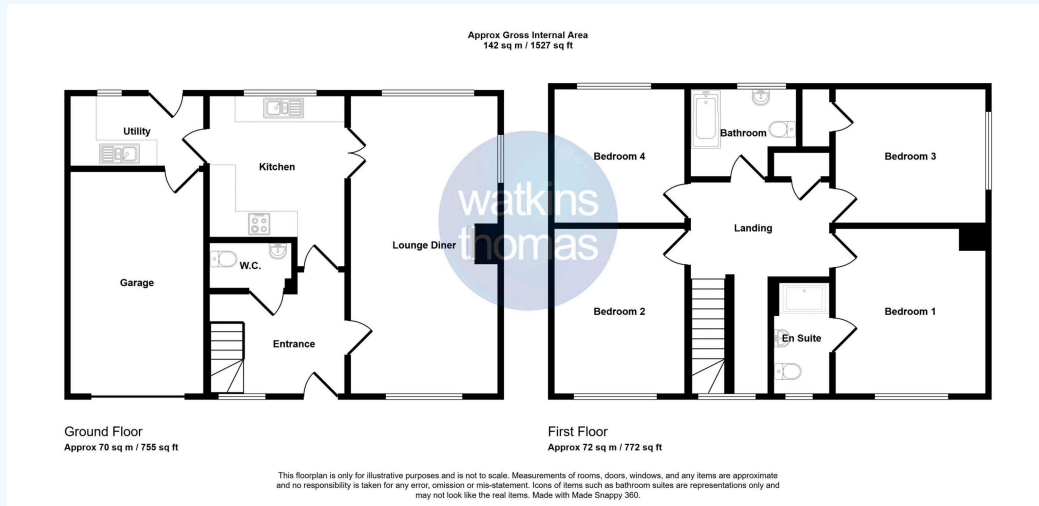
