Entrance Porch

Built in cupboard.

Sitting Room

Open staircase with storage cupboards to first floor. Wood block flooring. Double glazed window to front. Door to kitchen. Double glazed French door to living room. Coved ceiling. Radiator.

Living/Dining Room

Double glazed double doors with window to each side, two double glazed windows, all to side. Double glazed window to front. Tiled floor. Two radiators.

Kitchen

Range of wall and base units with granite work surface above and two circular inset sinks with mixer tap. Stoves electric double oven. Indest four ring electric hob and stainless steel extractor fan above. Integrated Bosch dishwasher. Integrated separate fridge and freezer. Floor to near ceiling cupboard. Space for washing machine. Tiled floor. Double glazed window and part double glazed door to rear.

First Floor Landing

Access to loft.





Bedroom One

Double glazed window to front. Built in wardrobes. Built in over stairs cupboard housing boiler. Radiator.

Bedroom Two

Double glazed window to rear. Built in wardrobes. Radiator.

Bathroom

Bath with separate shower above, low level WC and glass circular sink with mixer tap. Tiled walls. Frosted double glazed window to side. Wall mount heated towel rail.

Outside

To the front of the house is a stone area offering off road parking for two vehicles. The main feature to this house is the large garden with mature trees, which is mainly to the side of the house. There are two paved terraced areas, one to the rear and a large one to the side. The house sits within approximately 0.25 acre.

Property Information

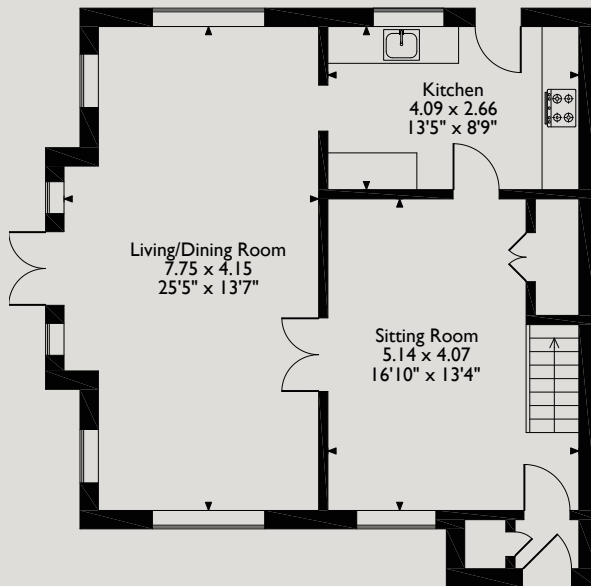

The garden is mainly covered by the Pulford Conservation area.

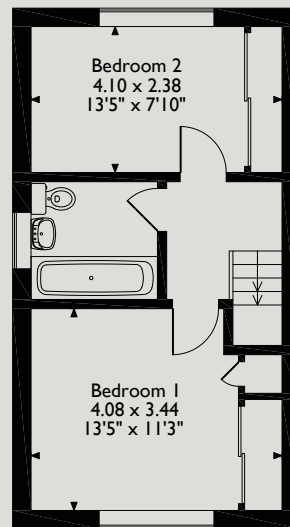


Floorplans
