DESCRIPTION

A substantial 1930s five bedroom semi-detached house in need of modernisation offering an excellent opportunity for updating and improvement. The property features generous living space including two reception rooms, a kitchen and a separate utility room. To the first floor are five well-proportioned bedrooms and a family bathroom.

The property benefits from a larger than average integral garage measuring approximately 24ft in length, together with ample off-street parking to the front. There is a particularly large south facing garden to the rear, providing excellent outdoor space and significant potential to extend, subject to consents.

LOCATION

The property is situated on a popular road in Westbury-on-Trym. This is a quiet, no-through road close to well regarded schools and green spaces including Horfield Common and Old Quarry Park. The property is conveniently situated within a short distance of Henleaze Road, Westbury Village and Gloucester Road - offering a fantastic range of independent shops, cafes, restaurants and amenities..

The area is well served by public transport and provides convenient access to Bristol city centre, the motorway network, Southmead Hospital and the regional shopping and leisure facilities at Cribbs Causeway.

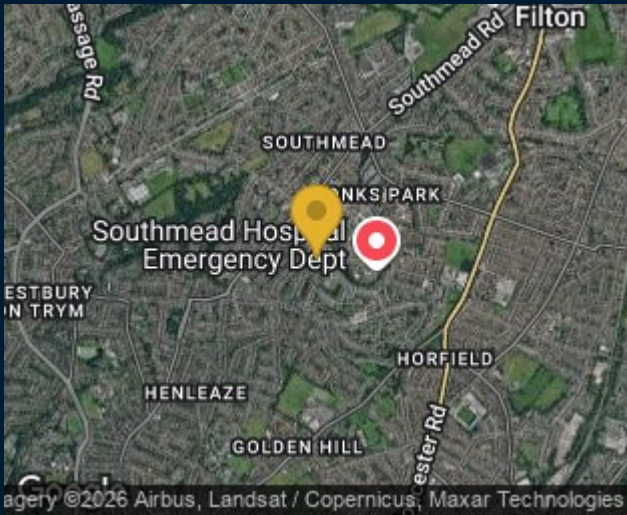
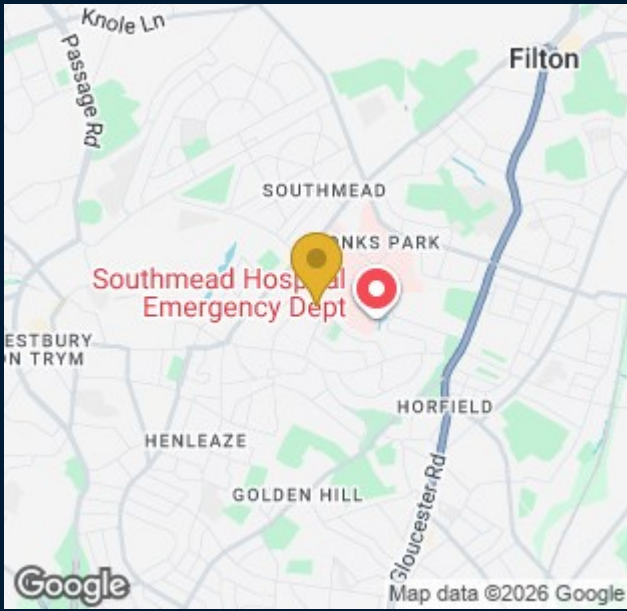

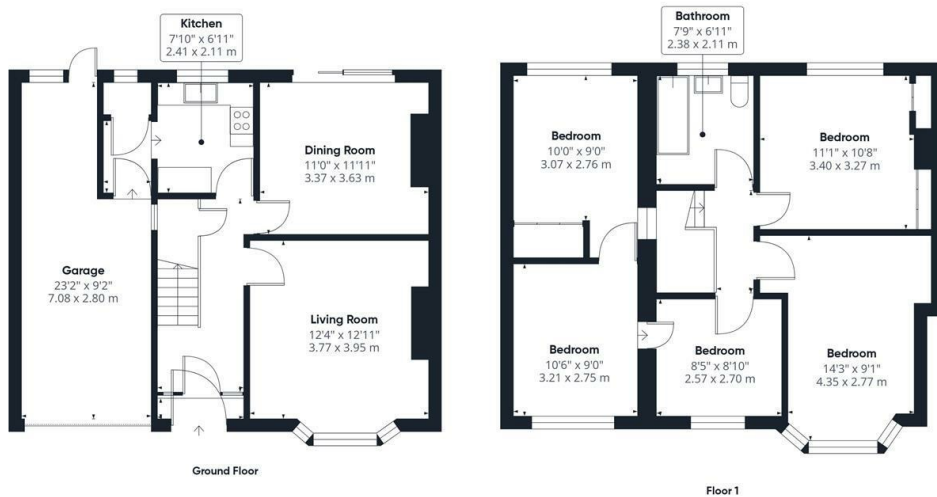
