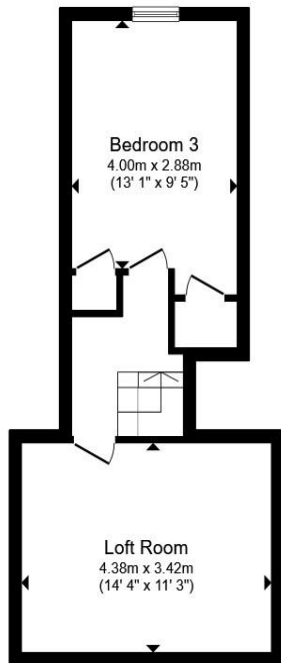

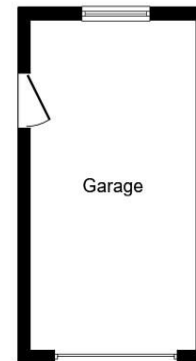




Ground Floor
