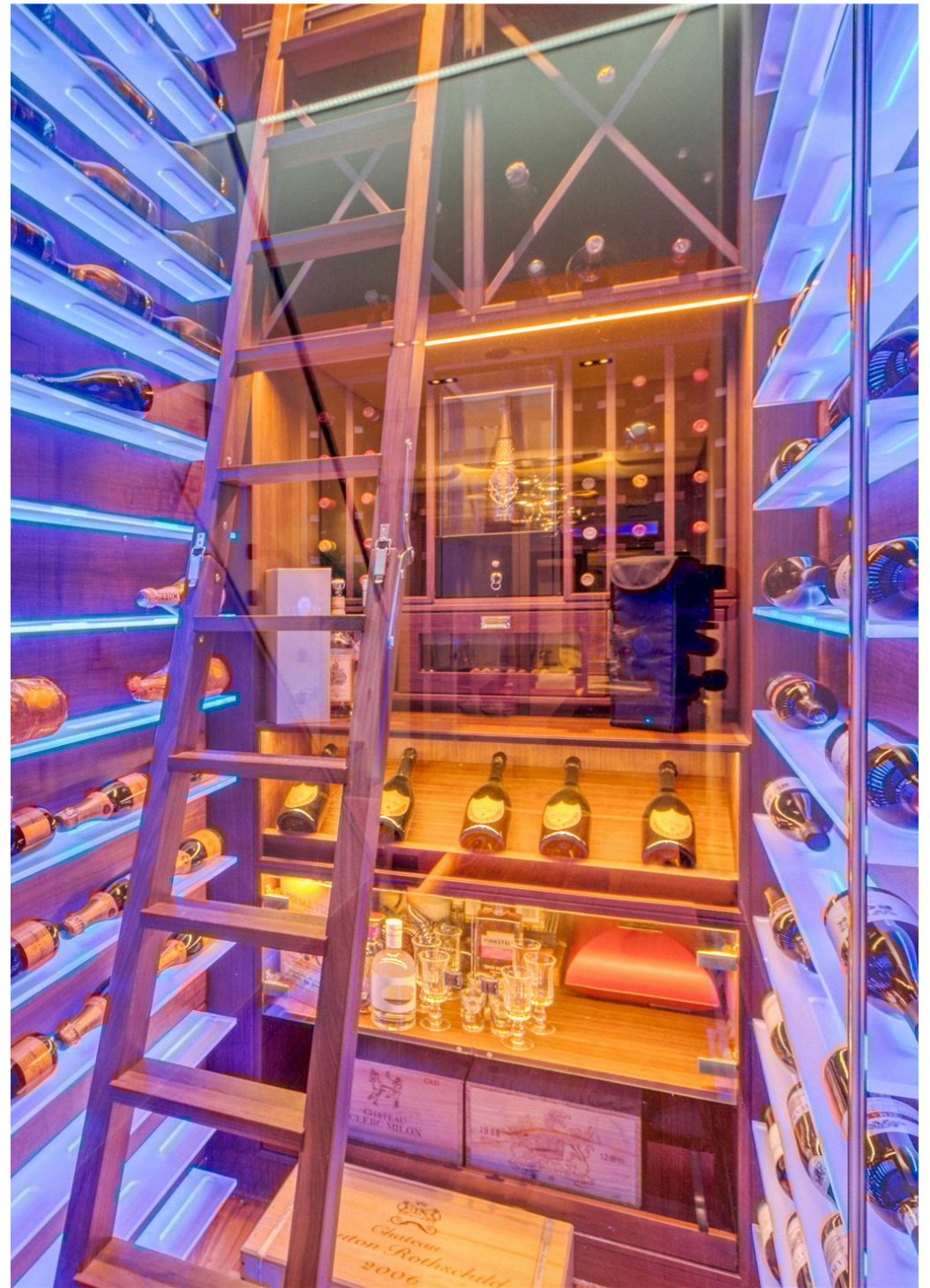

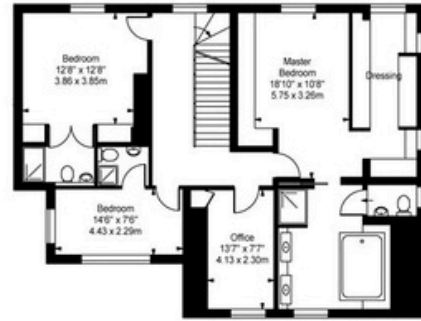

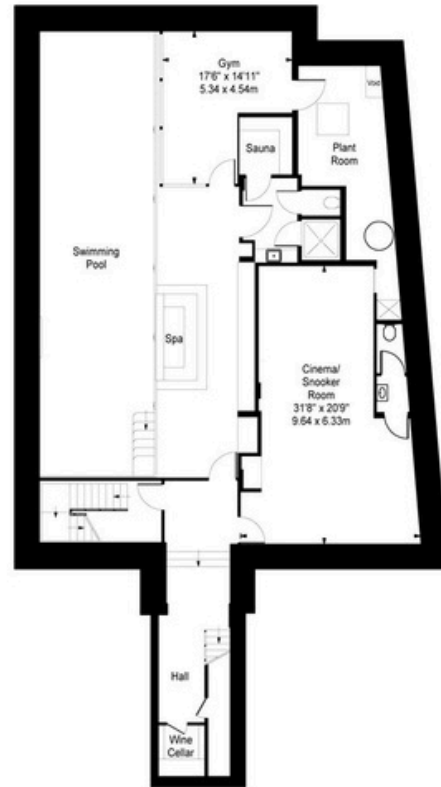




The Bishops Avenue, N2

Second Floor



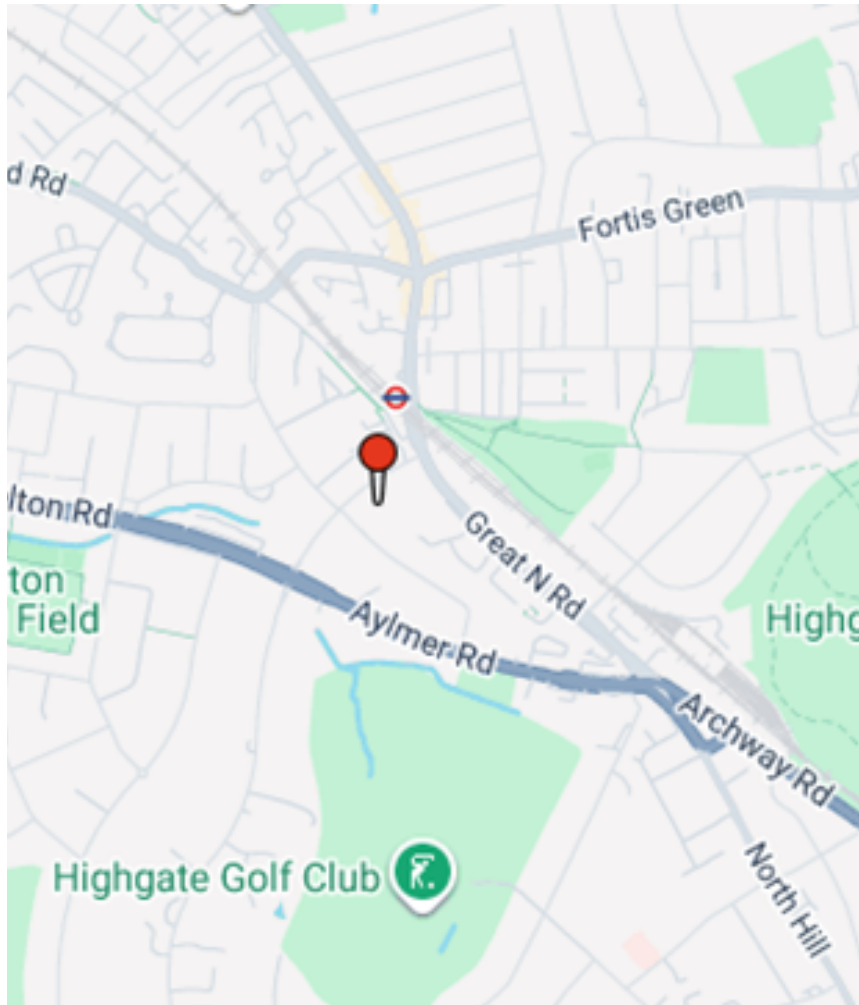
