BEDROOM FIVE

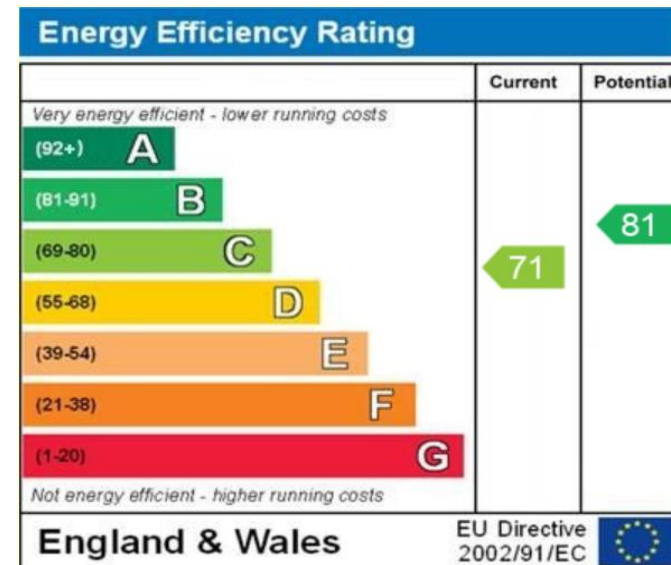
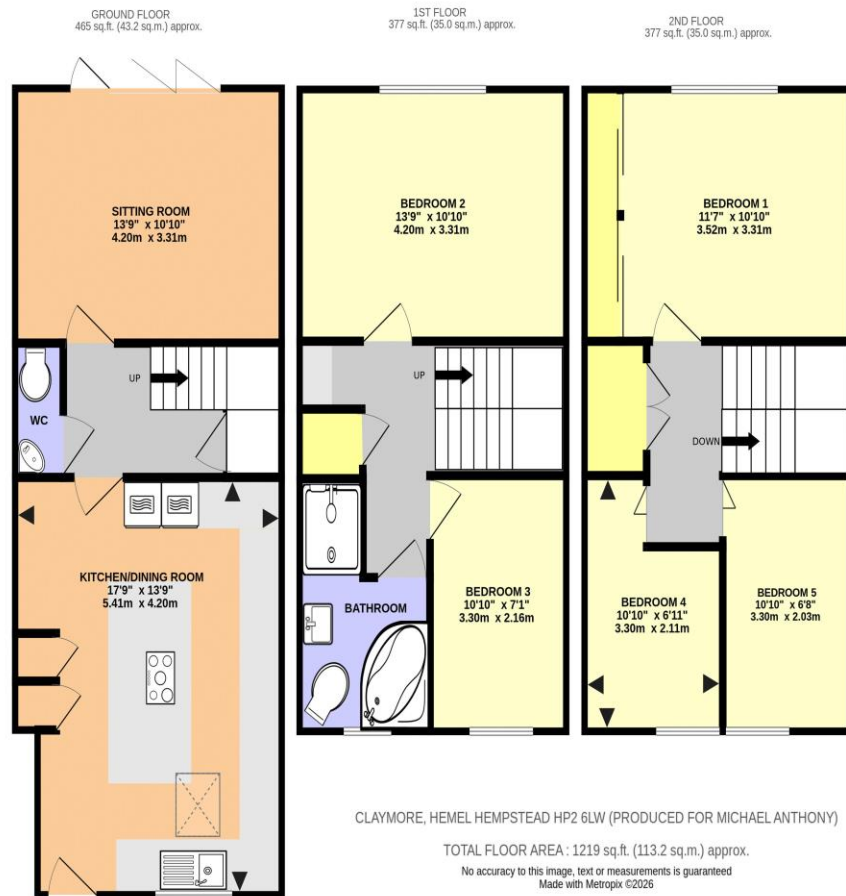
