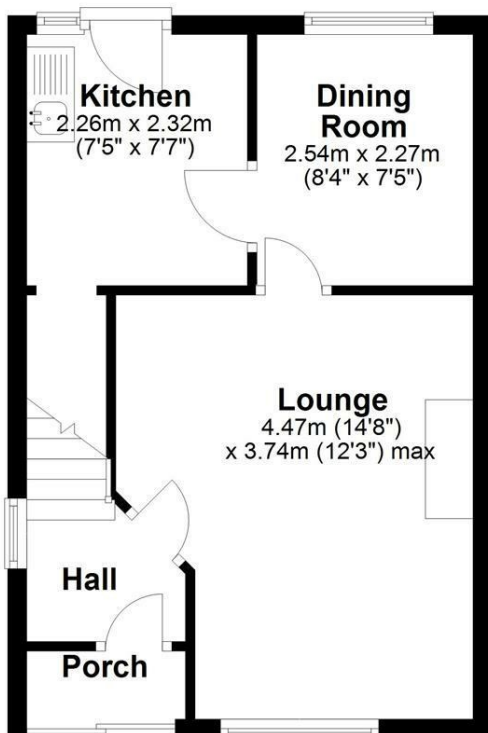

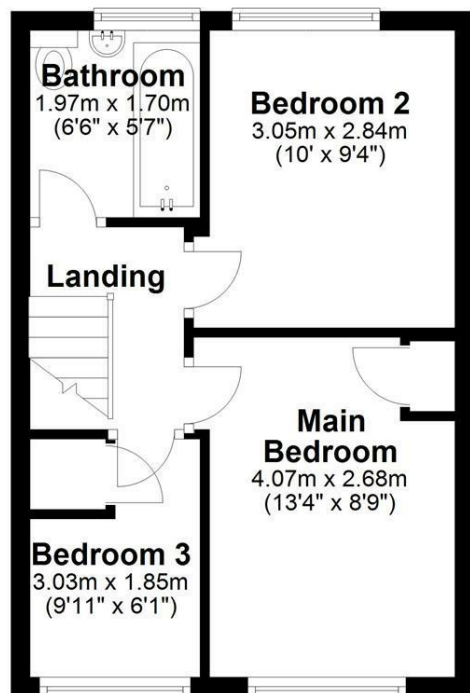




Ground Floor




First Floor

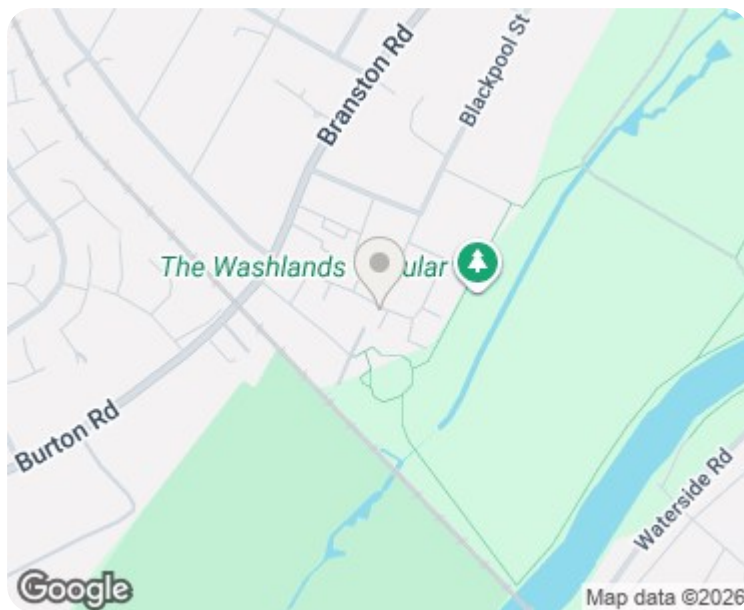
