



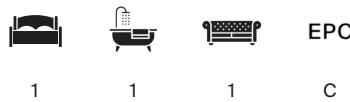

Large windows bring in abundant light, while a private balcony extends the living space. To the rear, the double bedroom is notably calm and secluded. Set away from the street and overlooking greenery, it feels particularly quiet, with fitted wardrobes and direct access to a beautifully appointed bathroom. Addison Gardens is a popular Victorian residential street, well positioned between the village-like atmosphere of Brook Green, the openness of Holland Park and the practical amenities of Shepherd's Bush. Transport links are also easily accessible.

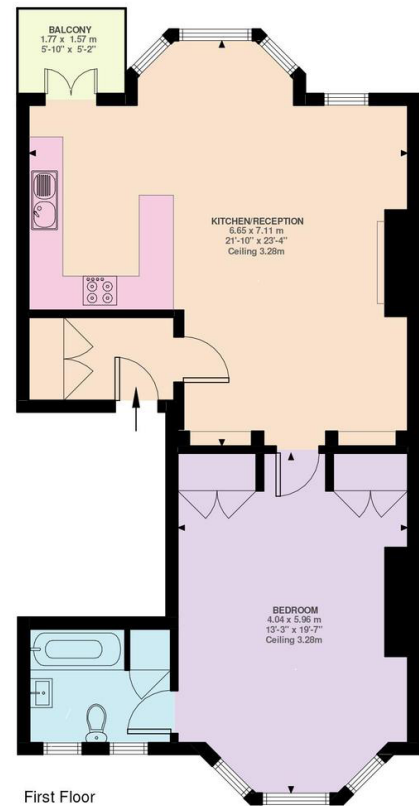
