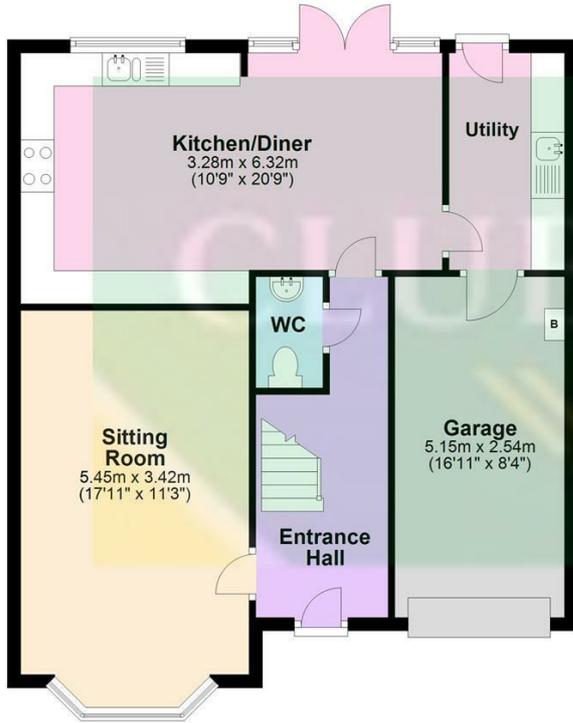

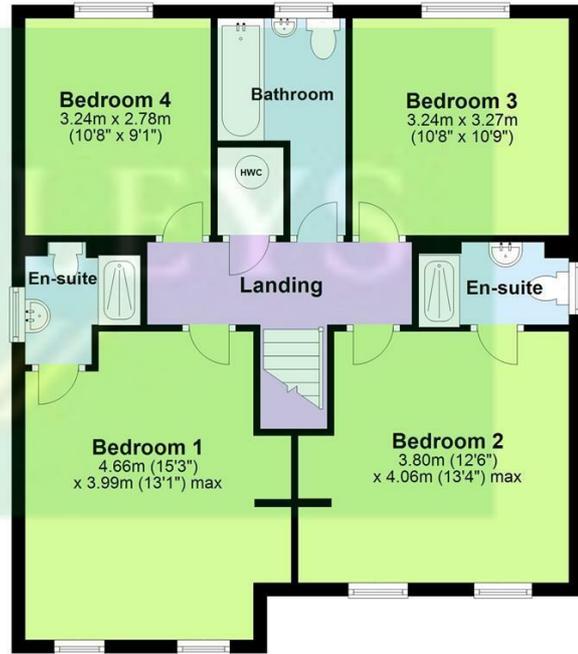
Ground Floor

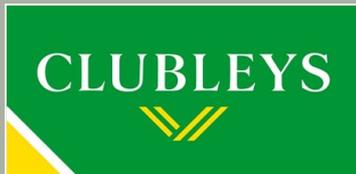
