Offered with no upward chain is this very well presented mature two bedroomed mid terraced property situated off Addington Road offering features to include refitted kitchen, uPVC double glazing, gas radiator central heating, refitted bathroom and offers 23ft lounge/dining room, an 11ft first floor bathroom, low maintenance courtyard style garden and a brick outbuilding for extra storage. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, three bedrooms, bathroom, front and rear gardens and outbuilding.
