This attractive three bedroom, two bathroom end-of-terrace townhouse offers well balanced accommodation arranged over three floors and is presented for sale in good condition throughout.

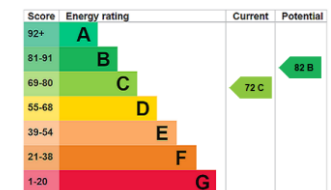
On the ground floor, the property features a fitted kitchen/breakfast room opening directly onto the south-facing rear garden. The first floor provides a bright reception room with wood flooring and two Juliet balconies overlooking the development, together with a bedroom and bathroom. On the second floor there are two further bedrooms, one of which benefits from an en suite bathroom.

The house also benefits from an integrated garage, off-street parking, generous storage space throughout, and a charming south-facing rear garden.
