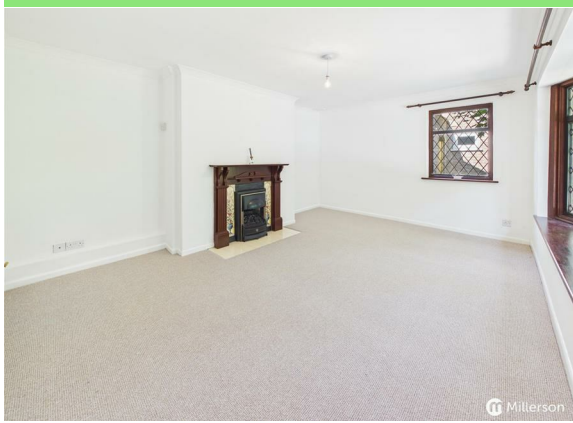

#### PROPERTY DESCRIPTION

Situated in the highly sought after location of South Tehidy is a rare opportunity to purchase this detached bungalow offered for sale with no onward chain. The property enjoys a very private south facing garden, a driveway providing off road parking and accommodation comprising an entrance hall, dual aspect lounge, kitchen with dining area, three bedrooms including a master with ensuite and an additional bathroom. Tehidy Gardens is an exclusive development on the edge of Tehidy Country Park and within close proximity to Tehidy Golf Course. The property has use of a communal tennis court, caravan and boat store and sits just a few miles of the North Cornish coast

#### LOCATION

Tehidy Gardens is a highly sought after residential development on the fringe of Tehidy Coutry Park with approximately 250 acres of woodland and within close proximity to Tehidy Golf Course and the main A30 providing transport links thought the county. The nearby historic mining town of Camborne offers a wide range of retail and leisure facilities, schools for all ages, mainline railway to London and several beaches are within a short drive with popular choices including Portreath less than 3 miles distant and both Gwithian, and Porthtowan within 7 miles.

The rear enjoys a particularly private enclosed garden boasting a sunny south facing aspect which is perfect for pets and children. Predominantly laid to lawn, there is also a paved and gravelled patio and a wide selection of mature bushes and shrubs to the boundaries along with a useful summerhouse.
