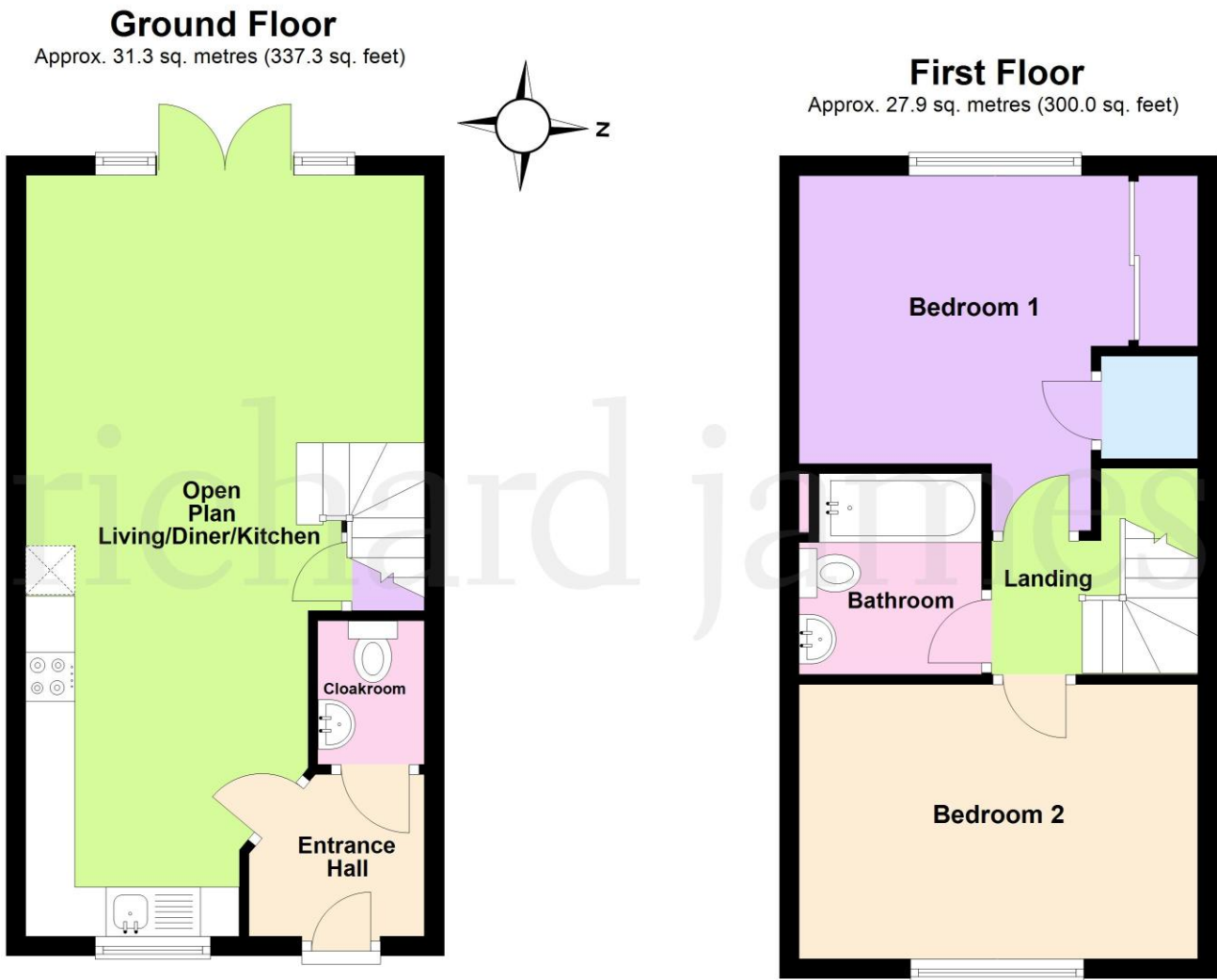




This plan is a guide only to represent the layout of the property and is not totally to scale. The bathroom fitments and kitchen units may vary in shape and size.

Offered with no chain and located within a short walk of the train station providing direct access to London St Pancras in just under an hour is this modern two bedroom terrace property built in 2022. The property benefits from uPVC double glazing, gas radiator central heating, built in kitchen appliances to include oven, hob, dishwasher and fridge/freezer, and further offers a cloakroom, a 25ft open plan lounge/diner/kitchen, two double bedrooms, a carport and a westerly facing low maintenance rear garden with a remote controlled awning. The accommodation briefly comprises entrance hall, cloakroom, open plan lounge/diner/kitchen, two bedrooms, bathroom, garden to rear, carport and off road parking.
