DESCRIPTION

Tastefully presented, attractive semi-detached house with off-road parking for two cars and landscaped south-facing rear garden set in an established residential area on the edge of Oakham.

Benefiting from gas-fired central heating and full double glazing, the property offers a very well maintained accommodation which features a refitted, contemporary kitchen. The interior is arranged over two storeys and briefly comprises:

GROUND FLOOR: Entrance Porch, WC, Hallway, Kitchen, Living/Dining Room; FIRST FLOOR: three Bedrooms, Bathroom.

UPVC double-glazed entrance door, built-in cloaks cupboard, internal doors to WC and Hallway.

Two-piece suite comprising low-level WC and wall-mounted hand basin with tiled splashback, radiator, solid wood floor, window to front.

Hallway 2.97m x 1.75m (9'9" x 5'9")

Radiator, solid wood floor, staircase with open spindles to first floor, access to Kitchen, door to Living/Dining Room.

Kitchen 2.95m x 2.29m (9'8" x 7'6")

Stylishly refitted with a range of contemporary units incorporating wood-effect work surfaces with upstand, high-gloss, soft-close cupboards and drawers and matching eye-level wall cupboards.

Integrated appliances comprise fridge-freezer, CDA electric double oven, Lamona induction hob with splashback and stainless steel extractor hood above, eye-level Lamona microwave and new Hotpoint slimline dishwasher. There is undercounter space with plumbing for washing machine

Modern white suite comprising low-level, rectangular hand basin with mixer tap and vanity cupboards beneath and panelled bath with mixer tap and Mira power shower above. Chrome heated towel rail, fully tiled splashbacks, tiled floor, electric mirror, shaver point, window to side.

Front Garden

The property is accessed via a shaped brick-paved driveway which provides off-road parking for up to two vehicles to the front and side of the house. Adjoining the driveway is a border with inset shrubs.

A hand gate to the side of the house links front and rear of the property.

Rear Garden

The fully enclosed rear garden enjoys a southerly aspect and is privately screened by mature bushes and hedging. The garden has been attractively arranged to include a paved patio immediately to the rear of the house, adjoining lawn with well-stocked borders and a paved area with a shed to the side.

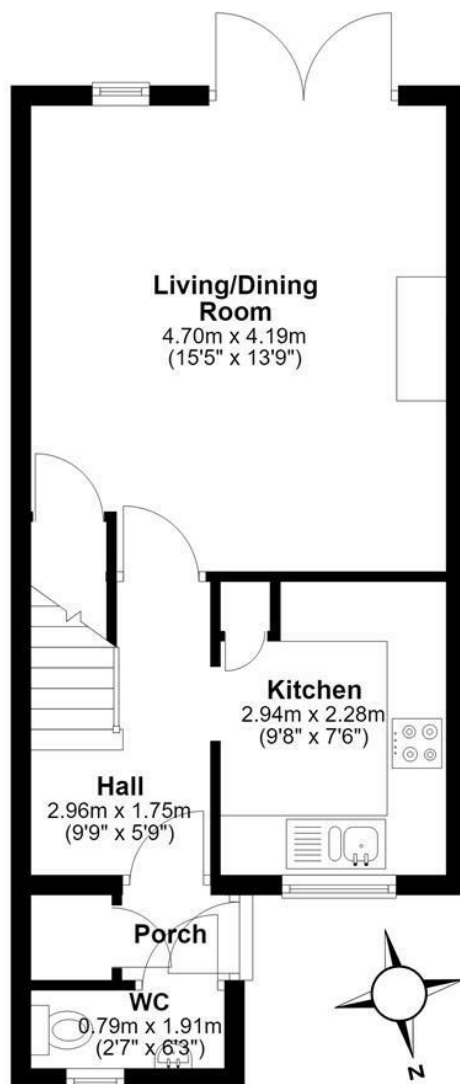

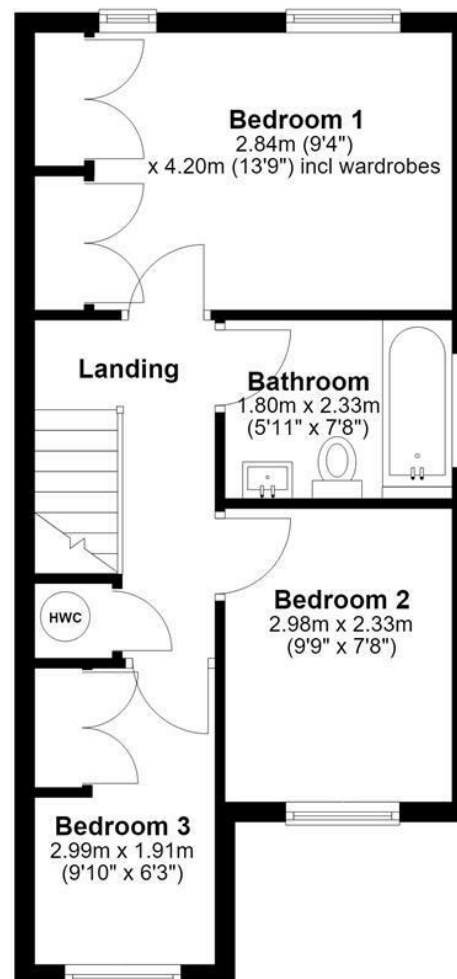
Ground Floor
