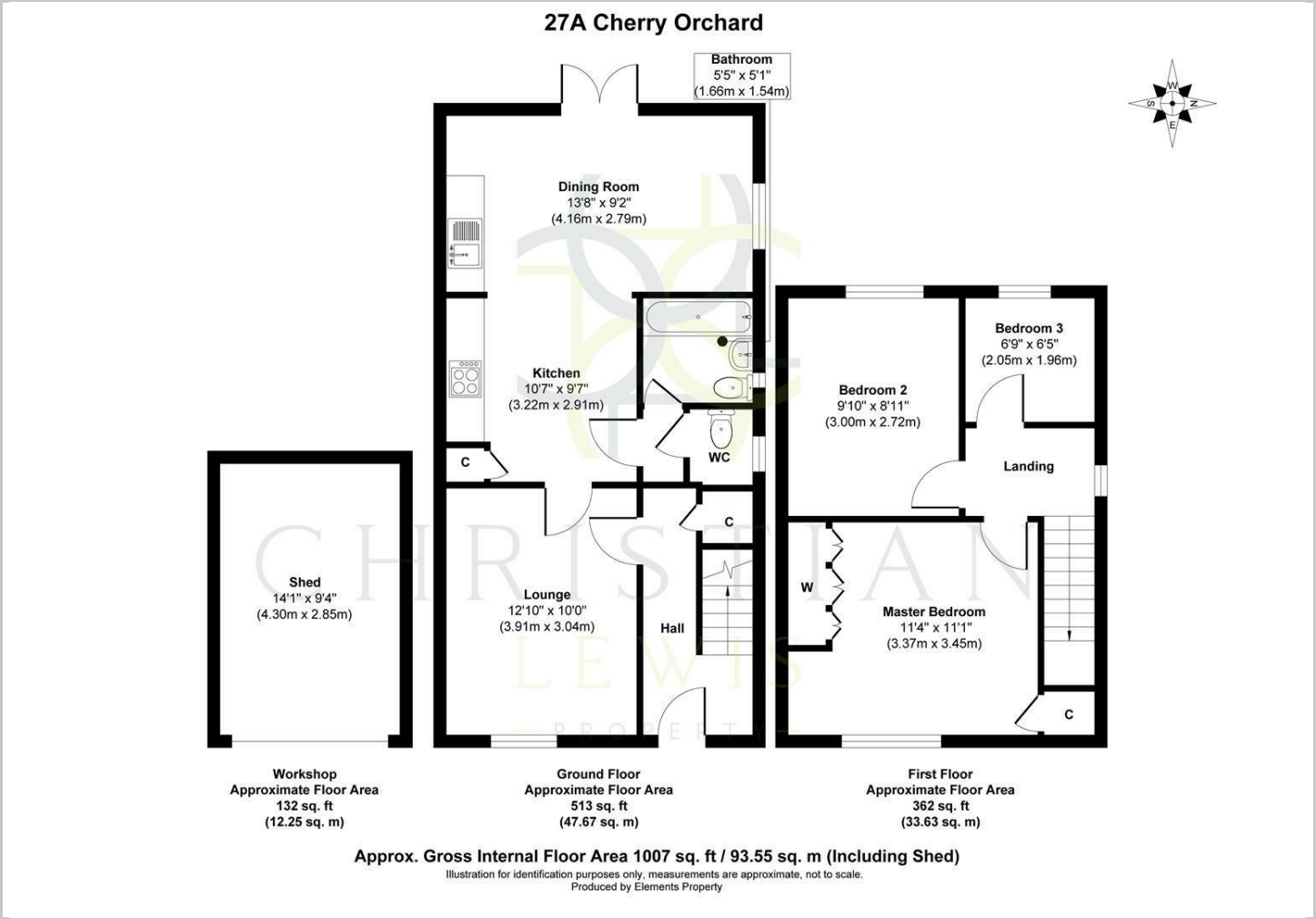

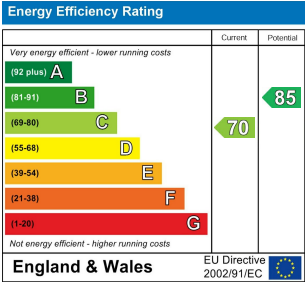
Floor Plans
