

GROUND FLOOR;

ENTRANCE HALL

Welcoming entrance hall with stairs off.

LIVING ROOM

14'6" x 11'2" (4.42m x 3.40m)

A generous living room with feature fireplace housing an electric fire, under-stairs cupboard and a window to the front elevation.

DINING KITCHEN

14'6" x 7'10" (4.42m x 2.39m)

With cream gloss wall and base units, laminated work surfaces and a tiled splashback. Integrated appliances include an Electric Oven, Electric Hob, Extractor Hood and a stainless steel sink unit.
