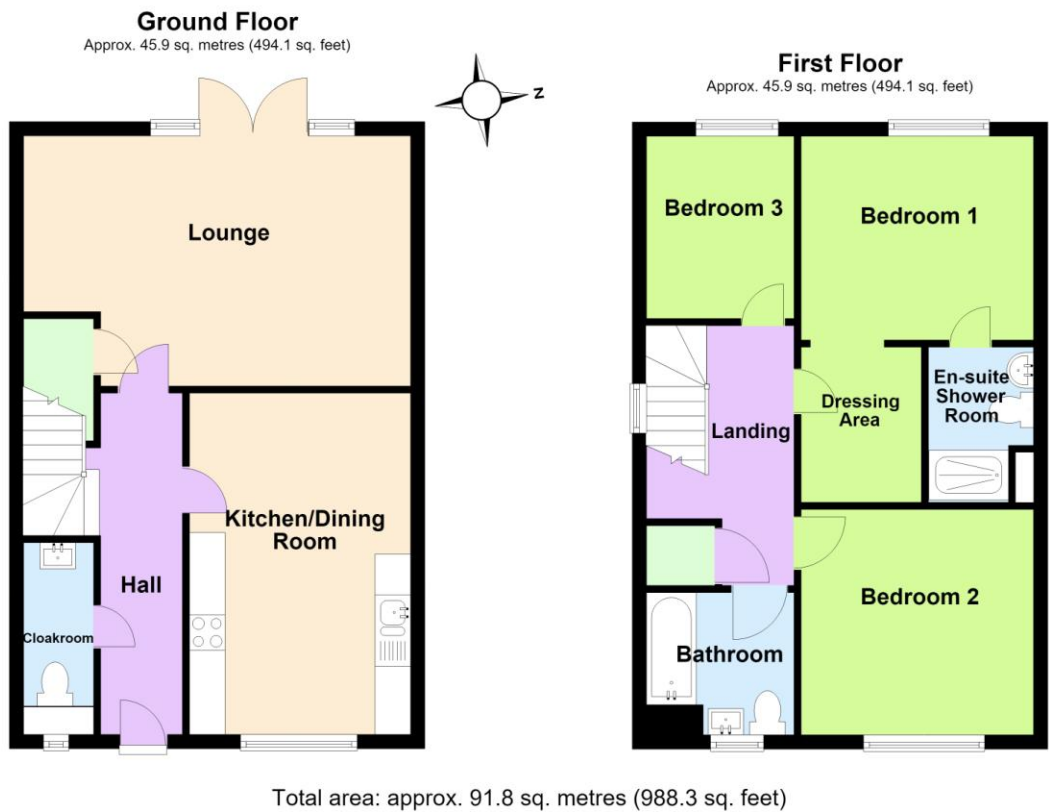




This plan is a guide only to represent the layout of the property and is not totally to scale. The bathroom fittings and kitchen units may vary in shape and size.

The accommodation briefly comprises entrance hall, cloakroom, kitchen/dining room, lounge, three bedrooms, ensuite shower room, family bathroom, rear garden and a driveway.
