ACCOMMODATION

The property is arranged over two floors and comprises:

GROUND FLOOR

ENTRANCE HALL

Allowing access to the property via a residential entrance door. The hallway features a staircase to the first floor, window to the front and a utility cupboard.

LOUNGE

A front facing reception room with two windows to the front elevation.

DINING KITCHEN

The full width dining kitchen is fitted with a range of wall and base units which are mounted with contrasting worksurfaces. There is a stainless steel sink unit, integrated oven, hob and extractor hood, space and plumbing for an automatic washing machine. There is ample room for a dining table and French doors which open to the rear garden.

FIRST FLOOR

LANDING

With access to the accommodation at first floor level. There is a window to the side elevation.

BEDROOM 1

A good sized bedroom with fitted furniture to include wardrobes and drawers. There is a window to the front elevation.

BEDROOM 2

A second good sized bedroom with a window to the rear.

BEDROOM 3

With a window to the front elevation.

BATHROOM

Fitted with a three piece suite comprising WC, pedestal wash basin and a panelled bath with a glazed screen, tiling and shower over. There is a window to the rear and a heated towel rail.

OUTSIDE

FRONT

To the front of the property there is a driveway which provides off street parking and continues to the side of the property. A gravel area to the front which offers additional parking potential.

REAR

To the rear of the property there is a good sized garden which is mainly laid to lawn and offers excellent privacy. A patio area adjoins the property and there is gated access from the driveway.

GENERAL INFORMATION.

SERVICES - Mains water, electricity, gas and drainage are connected to the property.

CENTRAL HEATING - The property has the benefit of a gas fired central heating system to panelled radiators.

DOUBLE GLAZING - The property has the benefit of PVC double glazed frames.
