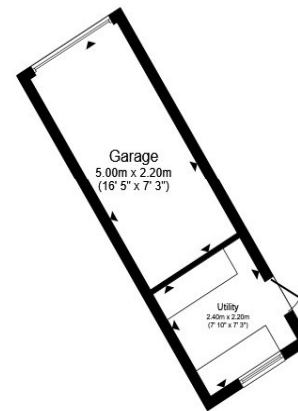




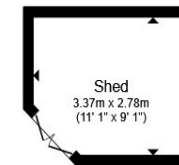
Ground Floor
