Extending to just under 850 square feet of accommodation, the property comprises of a large bay-fronted reception, separate dining area with modern galley kitchen adjacent, two bedrooms & a modern bathroom suite with shower over bath. Access to the rear garden is through the French doors in the dining area. There is also a share side access, usable by both the ground floor and upper floor apartments.

The property is located on the Fulham Palace Road, providing quick access to Bishops Park, the River Thames and local hotspots such as the Crabtree pub and the famous River Cafe. Transport links into Central London are easy via nearby Hammersmith Broadway underground station (Piccadilly, District & Hammersmith & City Lines).
