

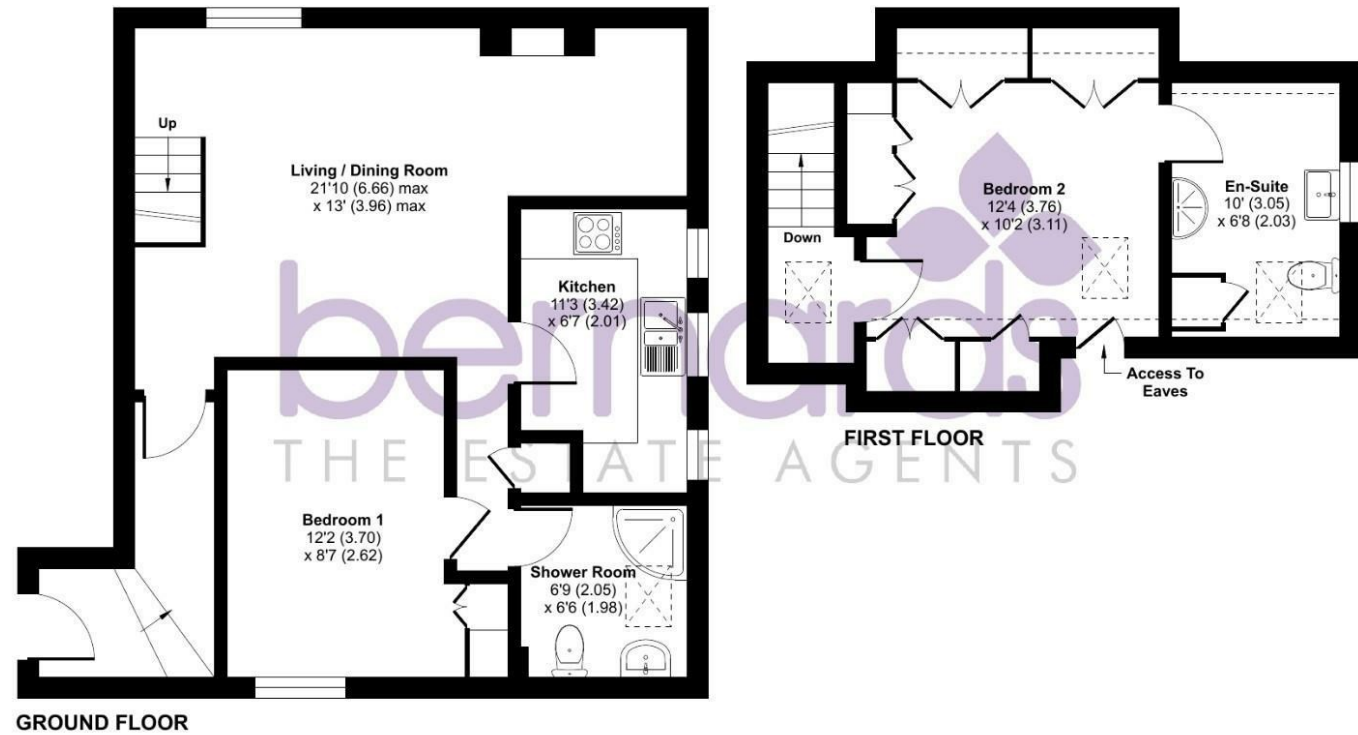

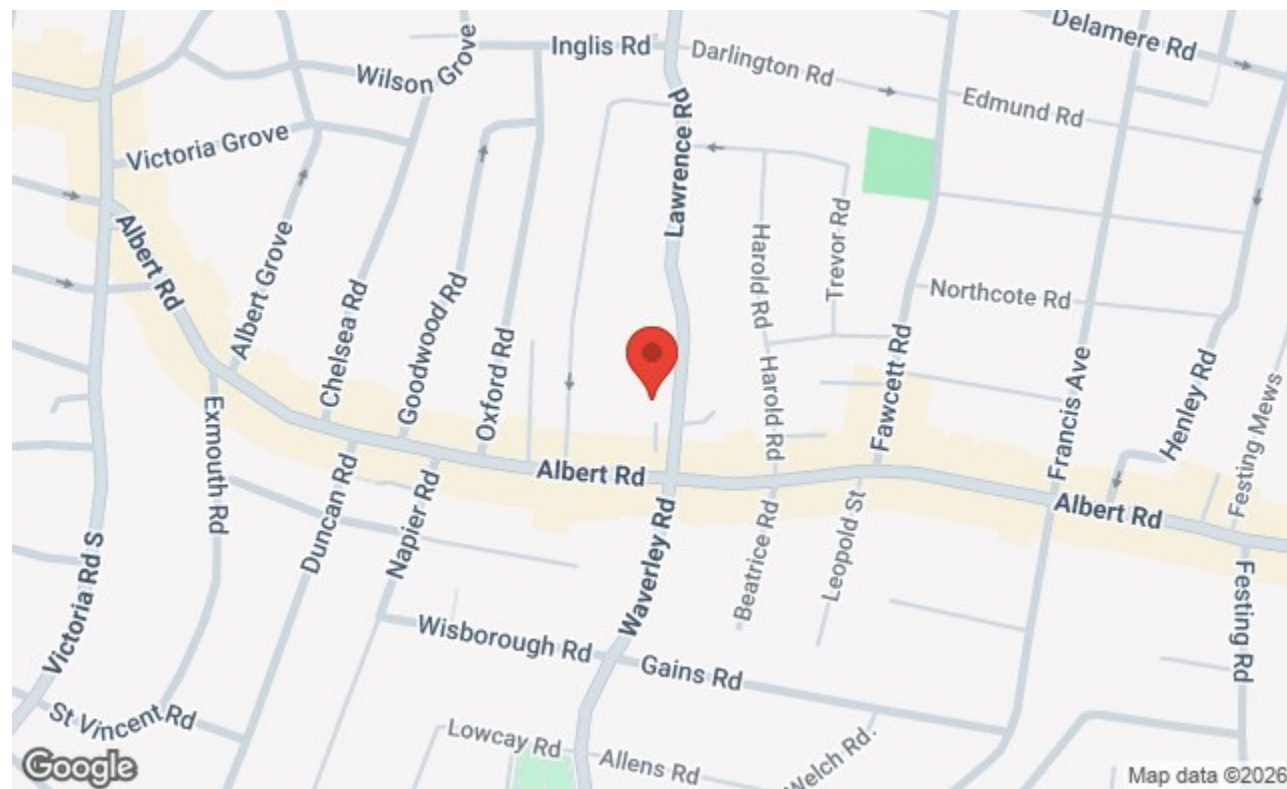

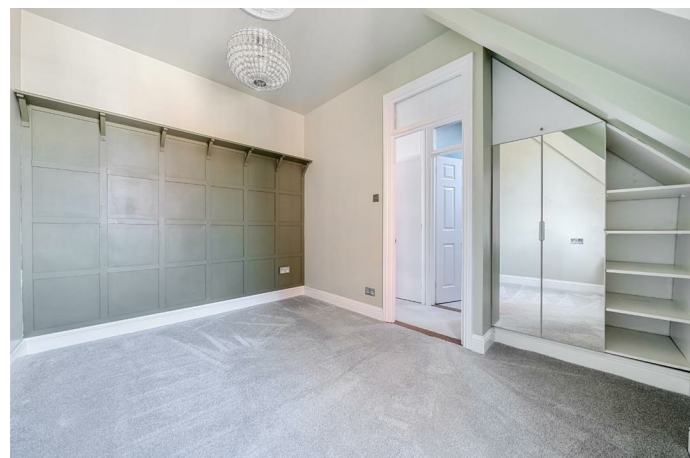
An auction can be closed at any time with the auctioneer permitting for the property (the lot) to be sold prior to the end of the auction.
