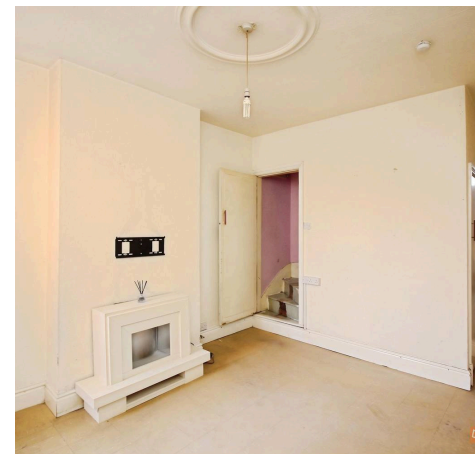

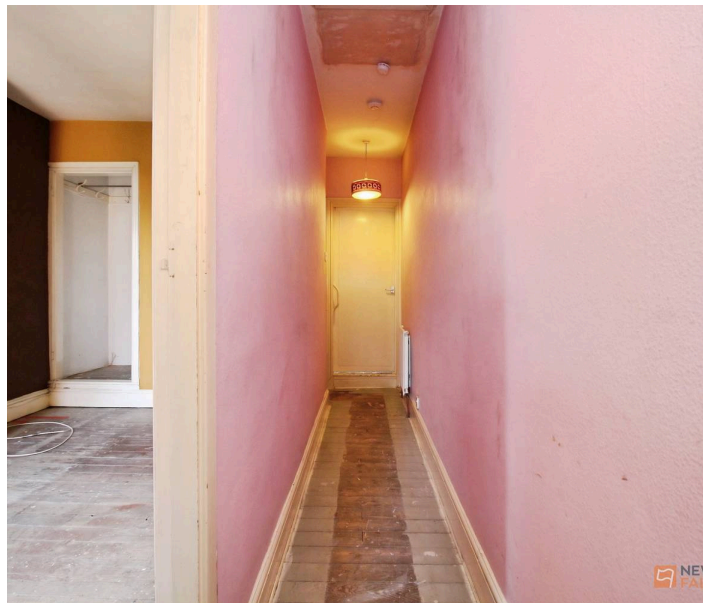


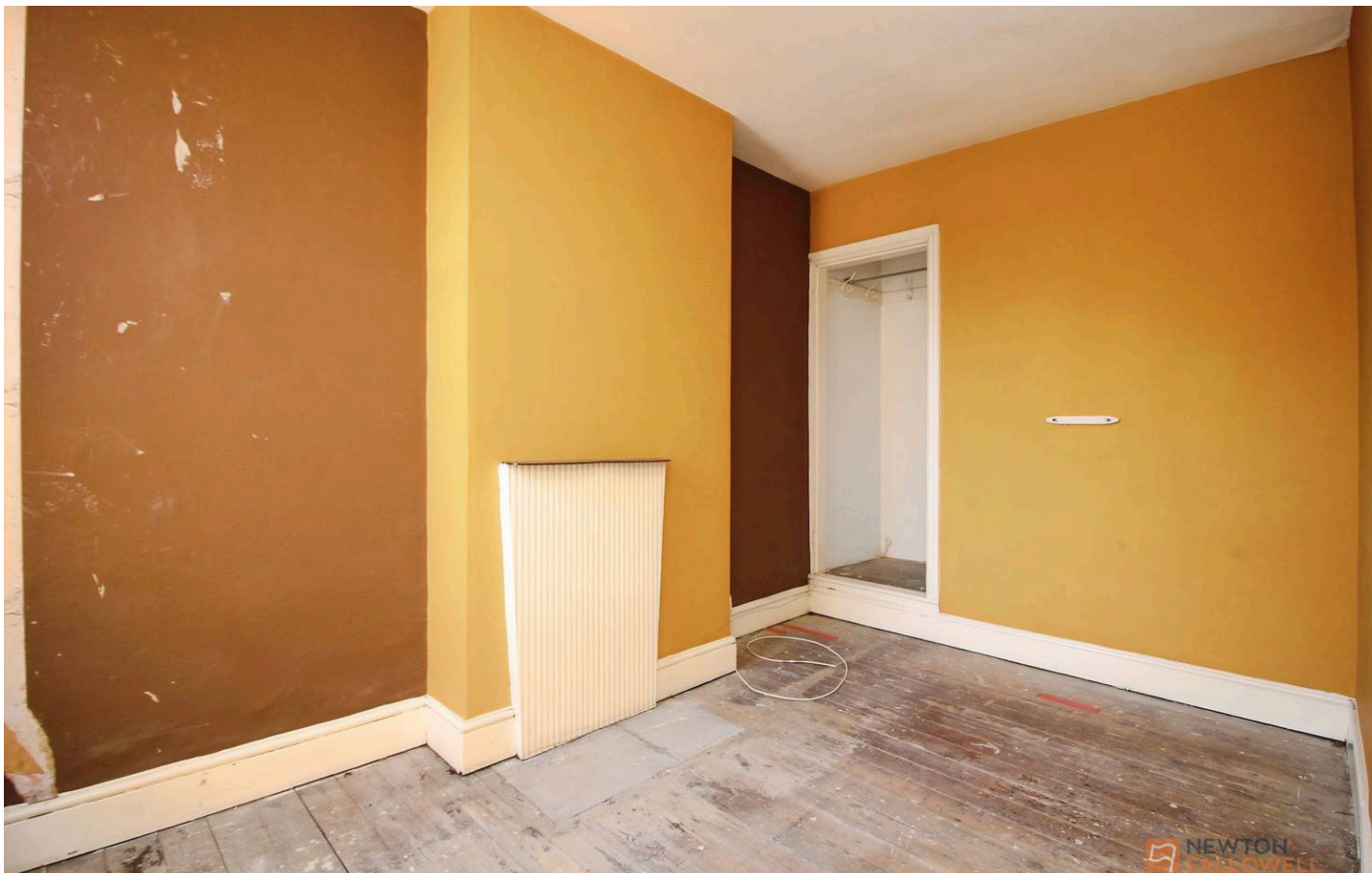
Making an Offer

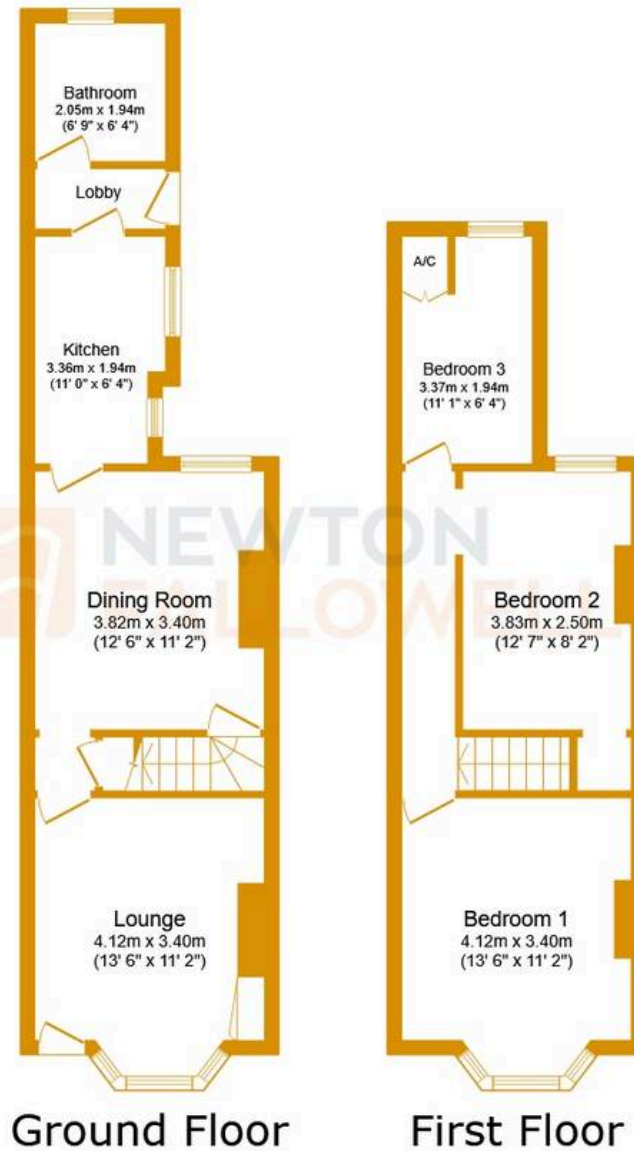
Referrals
