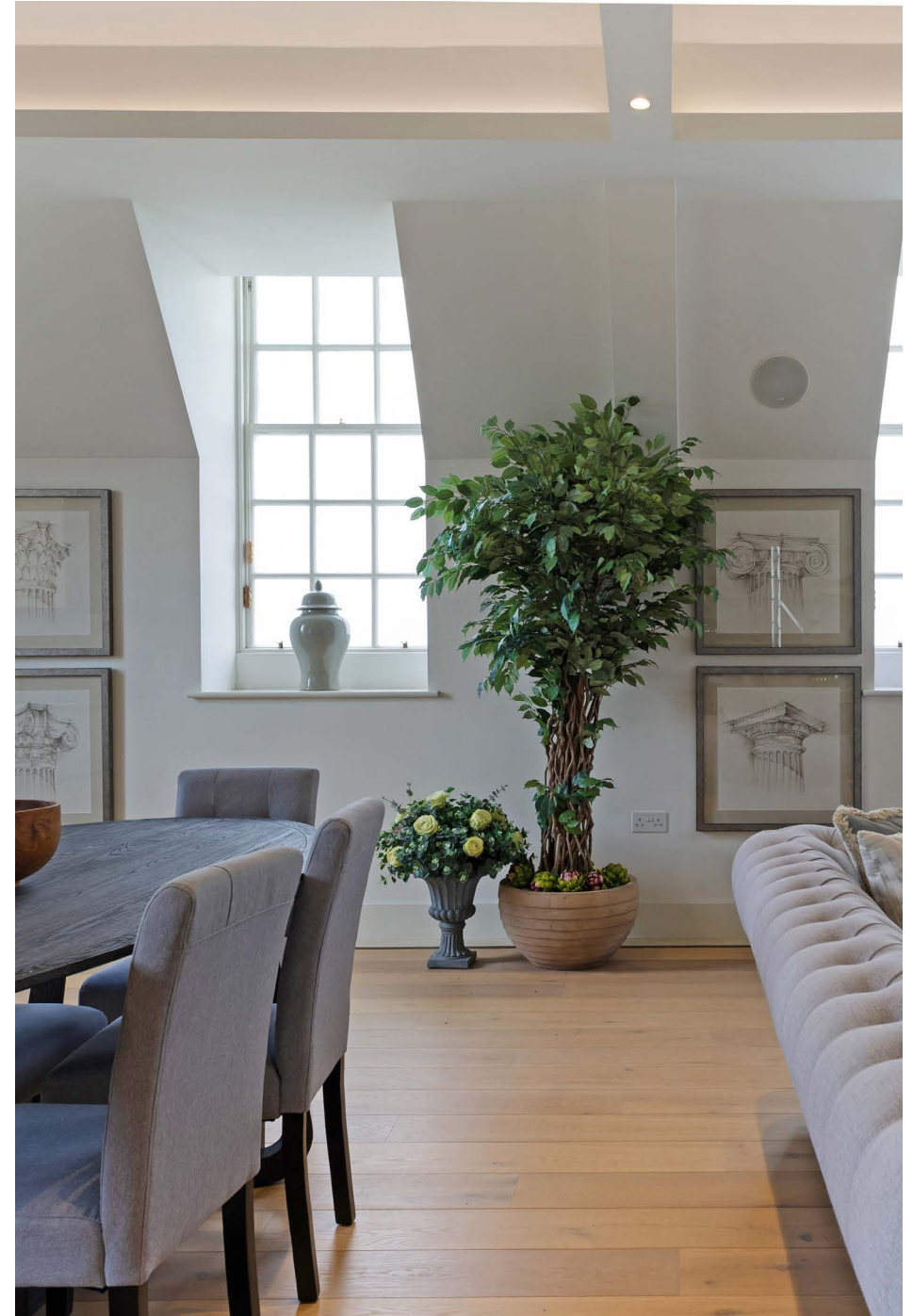

EXCEPTIONAL APARTMENT IN GRAND BUILDING IN RICHMOND.

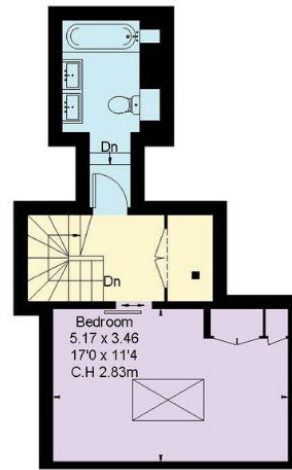

Further notable features include a gym and swimming pool, screening room and underground car parking. Residents will also benefit from a 'town car' with a service in to Richmond town centre. 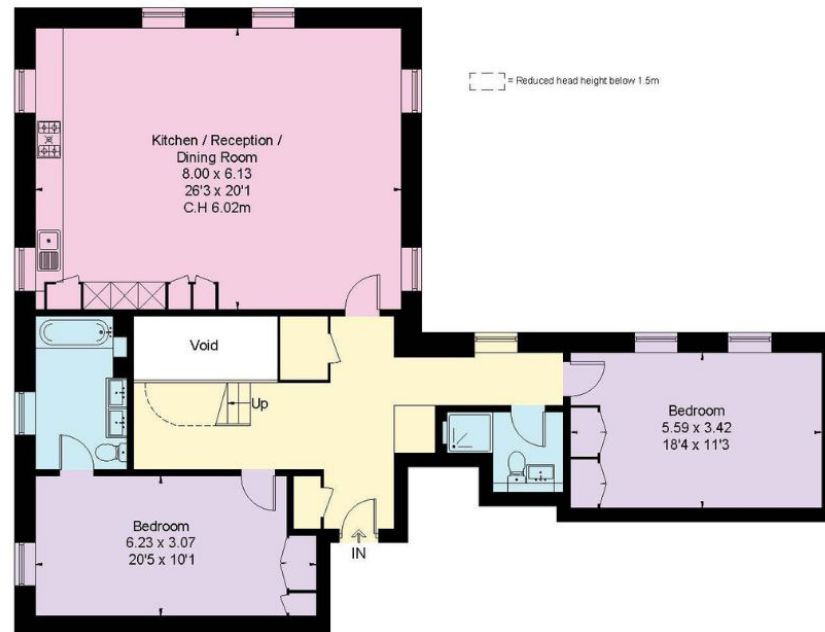








Top Floor
