Fitted with a range of base and wall units. Work surfaces with breakfast bar. Single drainer sink unit. Appliances of oven and hob. Space for washing machine and fridge/freezer. Johnson & Starley Hi Spec J32 gas warm air heating system. Window to the rear elevation. Part tiled walls.

Main side entrance door. Tiled flooring.

Suite of WC. Wash hand basin. Window to the side elevation. Tiled flooring.

First Floor Landing

Airing cupboard with cylinder. Access to roof void. Window to the side elevation.

Bedroom 1

9'1" x 8'9" + 8'1" x 6'10" (2.77m x 2.67m + 2.46m x 2.08m)

An extended rear facing room with window to the rear elevation. Range of wardrobes with top cupboards. Small dressing table.

Bedroom 2

9'1" + door recess x 10'11" to wardrobes (2.77m + door recess x 3.33m to wardrobes)

Window to the front elevation. Range of wardrobes. Top cupboards. Small dressing table.

Bedroom 3

Window to the front elevation.

Bathroom

6'0" extends to 7'0" x 12'3" max (1.83m extends to 2.13m x 3.73m max)

Fitted with a five piece suite with four of the range being in courageous pink. Comprising of a corner bath, wash hand basin, bidet, WC and shower cubicle with Triton T80 electric shower. Tiling to the walls. Step up to bathing area. Window to the rear elevation.

Outside

The property occupies a pleasant corner plot position on the corner of Broad Oak and Charterfield. There is a small garden area at the rear and off road parking with access to the double garage.

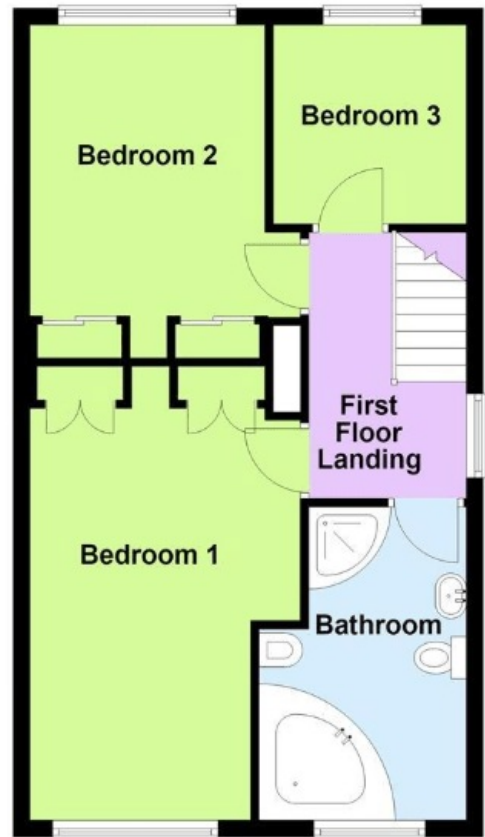

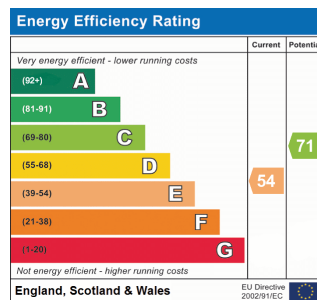
