## LOCATION

Conveniently located between Weybridge town centre and the train station for commuting into London Waterloo, therefore offering a balanced lifestyle for a family. The town centre has all that you need including Waitrose and a number of cafe's, pubs and restaurants along with the River Thames. The town has a number of leisure pursuits available including many river walks on your doorstep. Beyond this, there are two health clubs (Weybridge Health and David Lloyd) along with St Georges Hill Tennis Club and Golf Club, Burhill Golf Club, Mercedes Benz World and The Brooklands Museum.




There are a number of excellent private schools in the area including St. George's College and Junior, Feltonfleet, Notre Dame, Sir William Perkins and The ACS International School as well as the state secondary school, Heathside. The A3, M25 and the M3 are within easy reach alongside bus routes which go directly to Walton-on-Thames, Hersham, Kingston and Guildford. The train station is located on the edge of town and provides regular service to London Waterloo. London Heathrow and Gatwick airports are accessed via the M25. Weybridge Town Centre 0.3 miles, Weybridge Station 0.6 miles, A3 5 miles, Cobham 4.5 miles, Esher 5 miles, M25 2.8 miles, Woking 7.5 miles. All times and distances are approximate.




Approximate Gross Internal Area = 263.6 sq m / 2838 sq ft
