Road Map



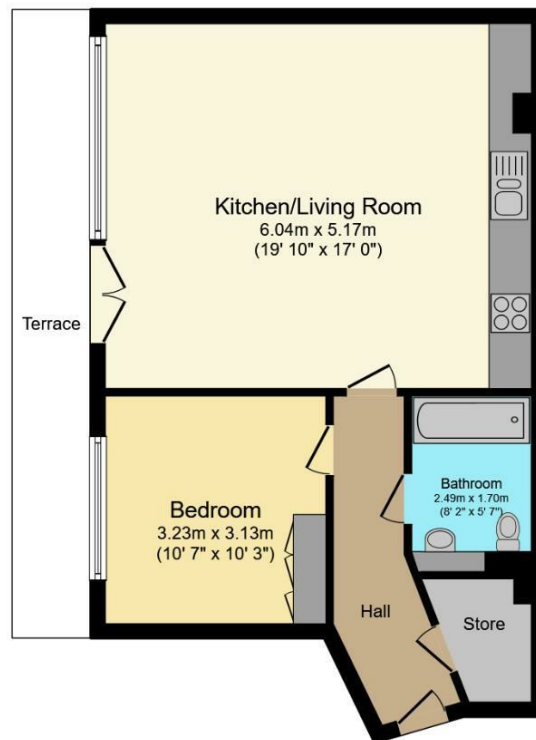
Hybrid Map

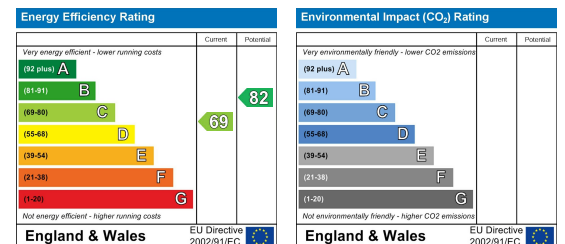
