Offered with no onward chain, extended one bedroom semi-detached bungalow situated in the village of Asfordby. The village has ample amenities to include a local primary school, doctors surgery, Co-Op Londis stores and the Crown pub. There are regular bus services to Melton, Grantham, Loughborough and Leicester.

The accommodation on offer comprises: entrance hall, kitchen, bathroom, lounge, office area, dining room and a double bedroom. Outside the property benefits from both front and rear gardens and is within two minutes walk of the Londis store.

ENTRANCE HALL Entering from the side of the bungalow into the entrance hall having doors off to:

KITCHEN 6' 5" x 13' 6" (1.98m x 4.13m) Fitted with a range of wall, base and drawer units topped with worksurfaces, breakfast bar with radiator under, stainless steel one and a half bowl sink and drainer with mixer tap, space and plumbing for a washing machine and a free standing cooker is included which has been serviced annually. Window over looking the front garden, wall mounted Worcester boiler, also serviced annually, and vinyl flooring.

BATHROOM 5' 7" x 6' 6" (1.71m x 2.0m) Comprising a panel bath with shower over, pedestal wash hand basin, low flush WC and a heated towel rail. Part tiled walls, extractor fan and vinyl flooring.

LOUNGE 10' 11" x 16' 8" (3.35m x 5.10m) A generous and nicely proportioned lounge having a front facing window, radiator, feature fireplace with a disconnected electric fire, carpet flooring and a door through to the office space, dining room and bedroom.

OFFICE AREA 6' 5" x 9' 9" (1.96m x 2.99m) An ideal space for a home office having built-in storage, radiator and an opening through to the dining room.

DINING ROOM 6' 6" x 13' 0" (2.0m x 3.98m) Having French doors to the garden making a great space to entertain, radiator and laminate wood flooring. Door to the bedroom.

BEDROOM 9' 6" x 13' 0" (2.9m x 3.97m) A double room having a window overlooking the garden, radiator and carpet flooring.

FRONT GARDEN Featuring a well- tended lawn and established shrubs, the front approach is enhanced by a neat pathway that leads to the gate, providing access to both the front door and the rear garden. There is also the option of renting a garage from MBC across from the property.

REAR GARDEN This south- west facing garden enjoys a paved patio adjacent to the bungalow, continuing along the side of the property. A formal lawn sits beyond, accompanied by a garden shed and an outdoor tap, with wood- panel fencing securing the boundary.

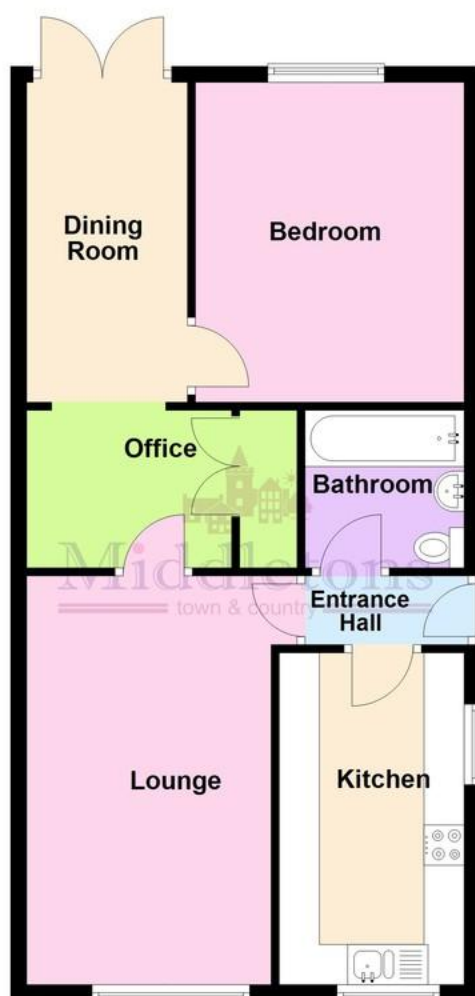
