Location

The garden is situated on the north west side of Woodstock Way within a quiet and established residential area of Hartlepool. The surrounding neighbourhood is predominantly made up of modern semi-detached and detached family homes with private gardens.

Hartlepool town centre lies approximately 4 miles to the south, providing a wide range of shopping, leisure and retail facilities. The nearby coastal town of Seaham and the city of Sunderland are also within convenient driving distance, offering further amenities and employment opportunities.

Description

A parcel of garden land situated within a well-established residential area of Hartlepool. The site extends to approximately 110 sq. m. (1,185 sq. ft.) and is positioned to the rear of existing residential properties, currently forming a former garden plot.


