This beautifully presented Victorian terrace is arranged over four floors and offers excellent entertaining space. The raised ground floor features a bright double reception with tall sash windows and elegant period details, plus a spacious eat-in kitchen with direct access to the decked garden. The lower ground floor can function as a self-contained area for guests, family, or an au pair, with its own entrance, a generous family room, double bedroom, kitchenette, and ensuite shower room. The first floor hosts the principal suite with ample wardrobes and a large ensuite with twin basins, walk-in shower, and separate bath. Three additional bedrooms all include built-in storage, complemented by two further shower rooms. Additional benefits include a south-facing roof terrace, a storage room, and a second entrance on the lower ground floor.
