A communal front door opens in the main lobby that has stairs rising to the first floor landing. The private front door opens into the central hallway that gives access to all rooms which include: two double bedrooms, a bathroom with a three piece bathroom suite, a large living room which is open plan to the kitchen. The kitchen has a range of storage units above and below the

laminated work top, electric oven with hob and extractor fan, and a washing machine. The property is dated and any new owner will look to spend capital to modernise.

Externally, there are communal gardens and allocated parking for one car.

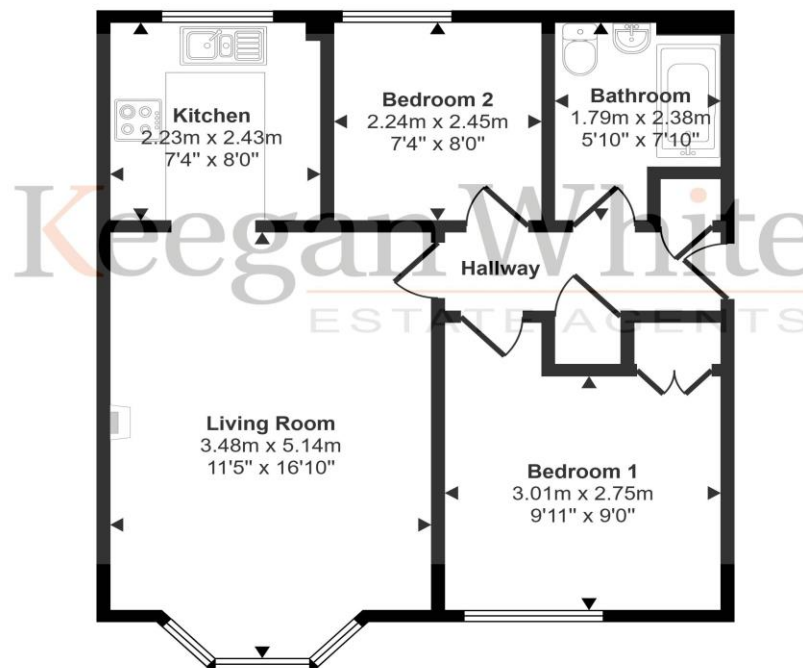
