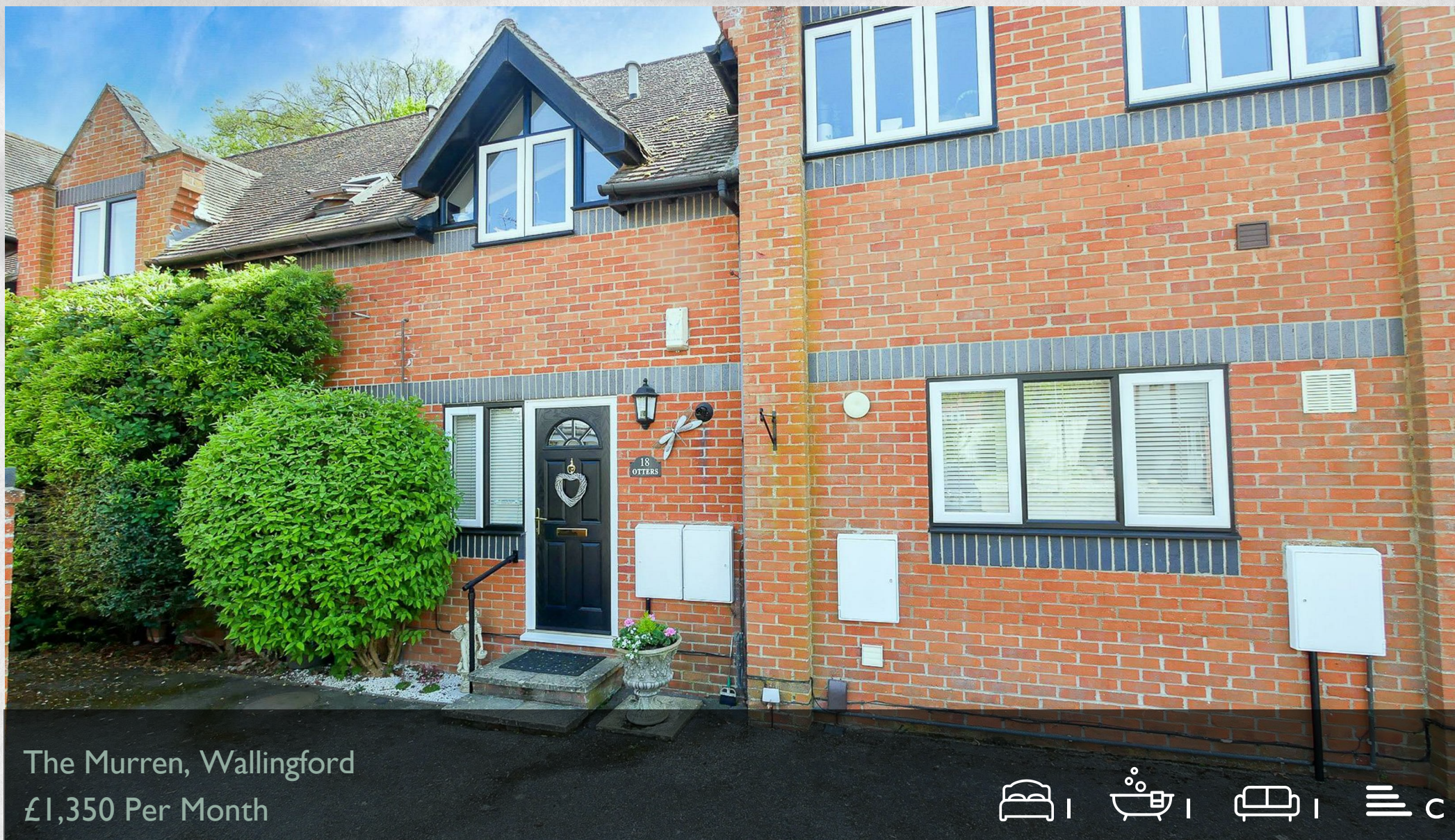

The property also offers two off-road allocated parking spaces, visitor parking, and an extensive private gated communal garden with tennis court, alongside direct access to river walks and private river frontage.





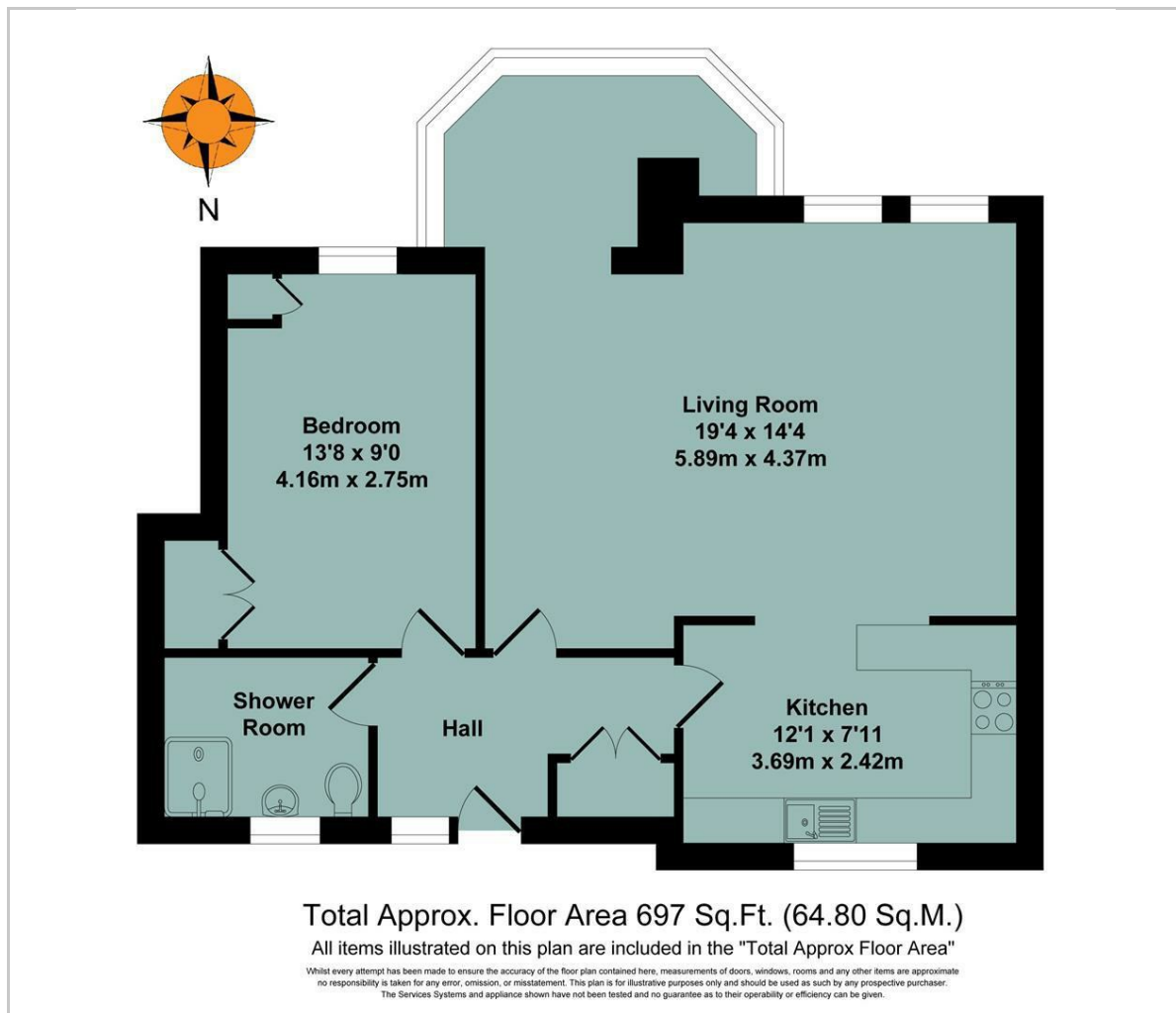
