ACCOMMODATION

uPVC double glazed entrance door leading into:

ENTRANCE HALLWAY

Stairs rising to the first floor accommodation, radiator and door giving access to:

LOUNGE

uPVC double glazed window to the front elevation, radiator, fireplace with electric fire feature and coving to ceiling. Door giving access into:

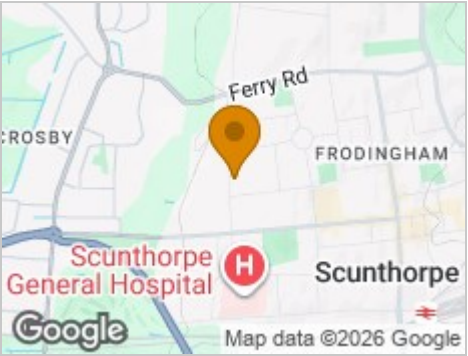
Road Map



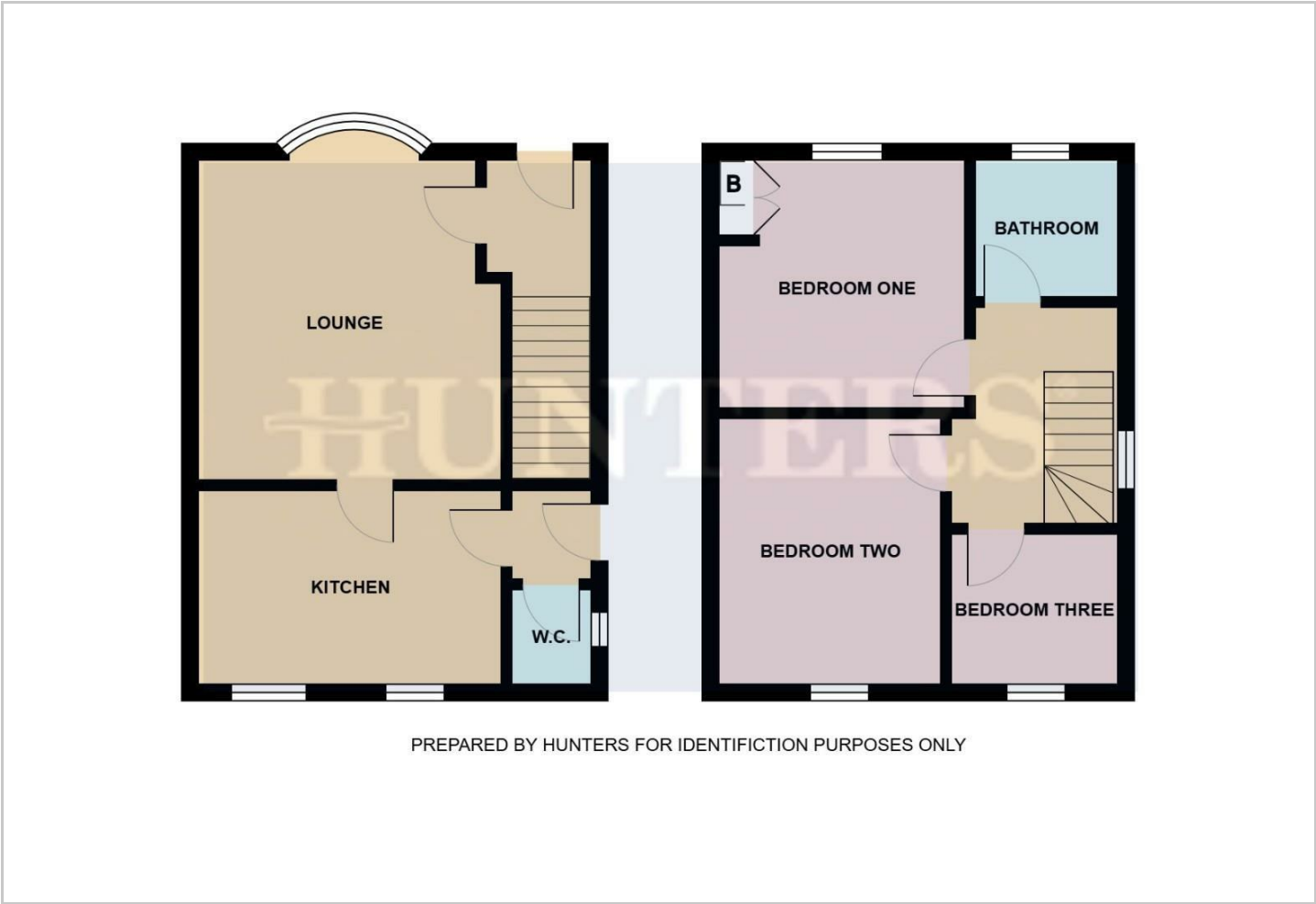
Hybrid Map



Terrain Map



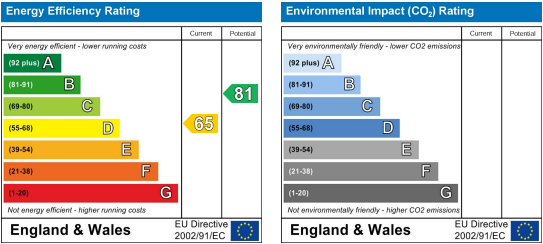
Floor Plan
