LOCATION

The property is located between Burleydam and Wilkesley which is a semi rural location. In Burleydam is the very popular Combermere Arms public house. The village of Audlem is located 4 miles away where there are a range of local shops, businesses, pubs and restaurants. Audlem has a local junior school. Whitchurch is located about 6 miles away and has 4 major supermarkets, high street shops, pubs and restaurants. Locally in around the area are excellent leisure and sporting activities from Rugby, Football, Cricket & Hockey clubs, golf courses lots of great walks.

BRIEF DESCRIPTION

Halls are delighted to be instructed to sell 3 Lodmore Lane by private treaty.

The property has a small front garden and path to the front door which opens into the entrance hall. The hall has the staircase, quarry tiled floor and latch door through to the sitting room. This has a feature brick fireplace with "Much Wenlock" cast iron stove with back boiler. There are exposed beams, window to the front and latch door to the kitchen/diner which has base and wall units, worktops, drainer sink unit, electric cooker and space and plumbing for a washing machine. There is a window and door to the patio garden. Off the kitchen is an arch to the open under stairs storage area.

The stairs ascend to the 1st floor landing which has a window to the rear, night storage heater and airing cupboard. There are two bedrooms with windows to the front overlooking the fields. To the rear of the house is a modern shower room with a shower enclosure, W.C, wash hand basin and window to the rear. The property has a mixture of solid fuel heating and electric night storage heaters.

OUTSIDE & GARDENS

To the front is a small area of garden. There is a shared drive to the side of the neighbours garden which leads to a gravelled parking area and the single garage. There is an l shaped garden with path leading from the garage to the patio garden with pergola above.

DIRECTIONS

From Whitchurch drive out on the A525 towards Nantwich and after about 2.5 miles turn right signposted Audlem. For the road for about 1.5 miles and turn right into Lodmore Lane and the property is located on the left hand side after about 1/4 of a mile.

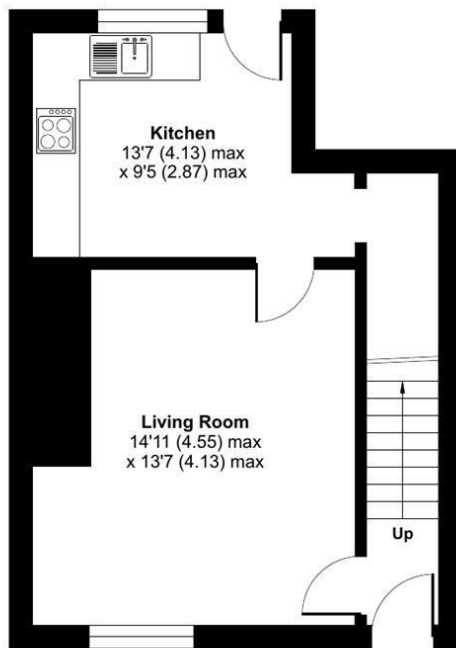
TENURE - FREEHOLD

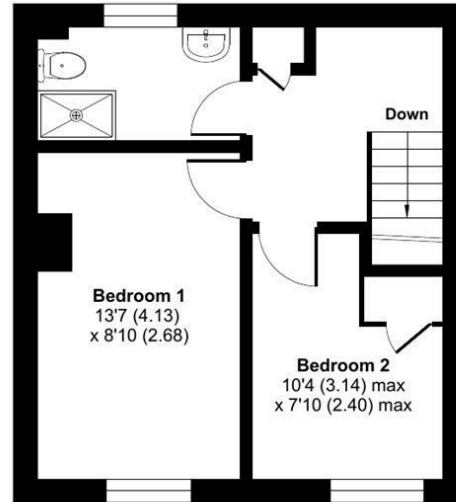
