Double glazed window to front aspect. Radiator, feature fireplace.

Double glazed window to front aspect, double glazed frosted door to side. Radiator, door to kitchen.

KITCHEN/UTILITY AREA

Two double glazed windows to rear aspect, double glazed double doors to garden. Fitted with a range of wall-mounted and base units with rolled edge work surface over, space for: washing machine, dishwasher, tumble dryer, fridge freezer and range cooker; radiator, one and a half bowl composite sink, tiled floor, open to utility.

Doors to bedrooms and bathroom, storage cupboard, loft access.

BEDROOM ONE

Double glazed window to front aspect. Radiator, built-in wardrobe, door to en-suite.

EN-SUITE

Double glazed frosted window to rear aspect. Low level WC, wash hand basin, heated towel rail, shower cubicle, part tiled walls.

BEDROOM TWO

Two double glazed windows to front aspect. Radiator, built-in wardrobe.

BEDROOM THREE

Double glazed window to front aspect. Radiator.

BEDROOM FOUR

Double glazed window to rear aspect. Radiator, built-in cupboard.

BATHROOM

Two double glazed frosted windows to rear aspect. Low level WC, heated towel rail, wash hand basin, bath with shower over, tiled walls and floor.

Off-road parking, gravel and shingle driveway.

REAR GARDEN

Mainly laid to lawn with patio area, two outbuildings, two side gated access, shed to remain, enclosed by wooden fence panelling.
