



Agents note: The property is leasehold with an assignable lease of 99 years starting in 28th July 1986. 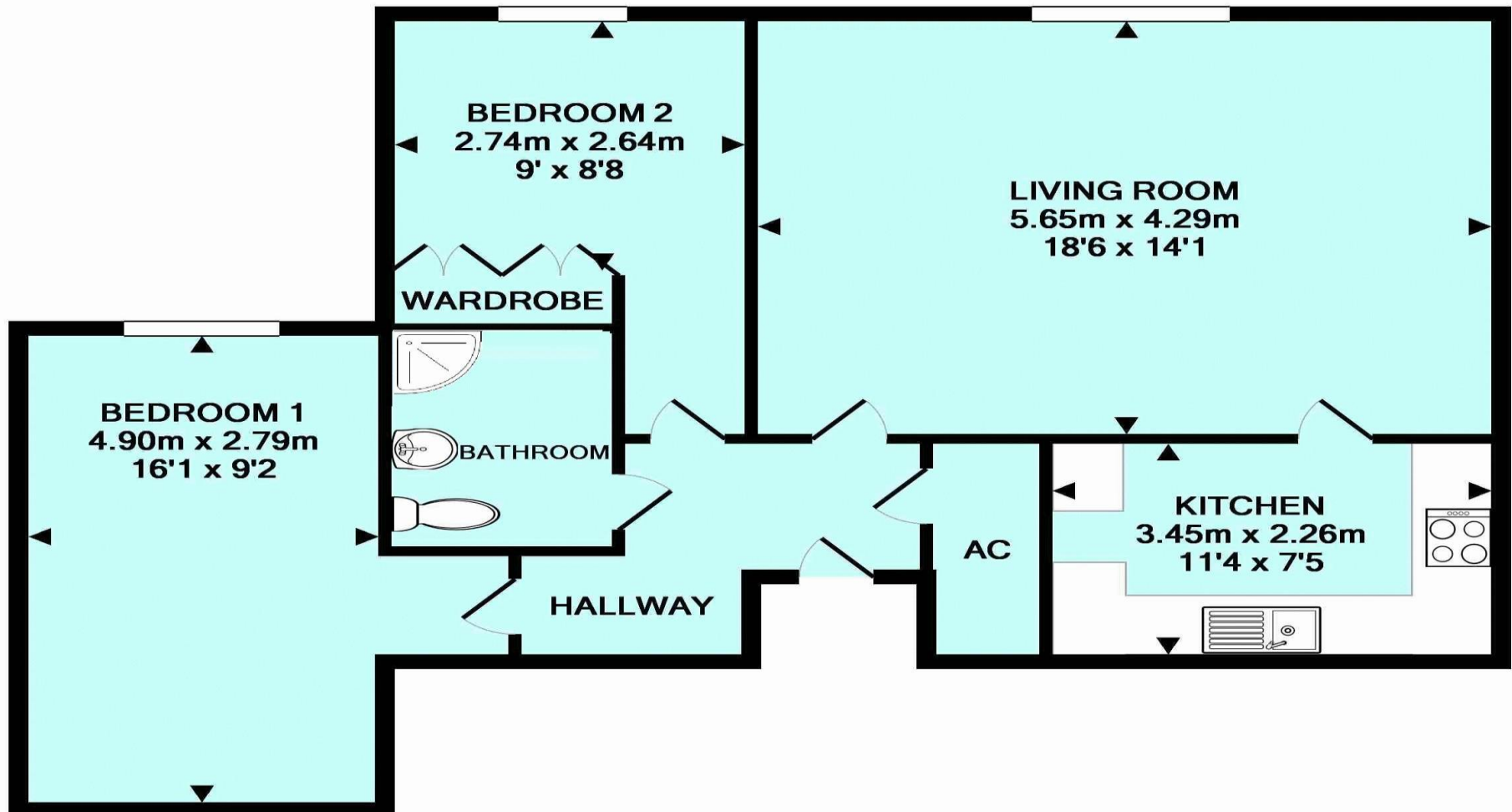
