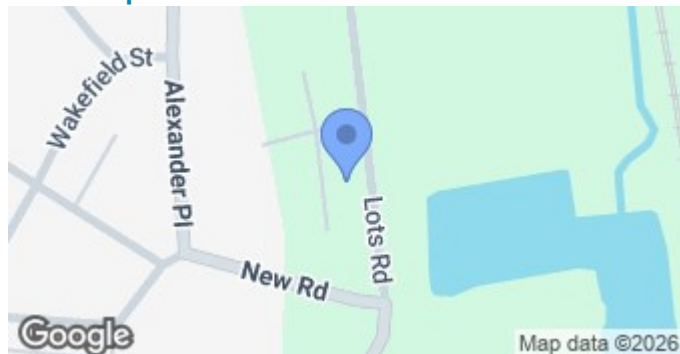

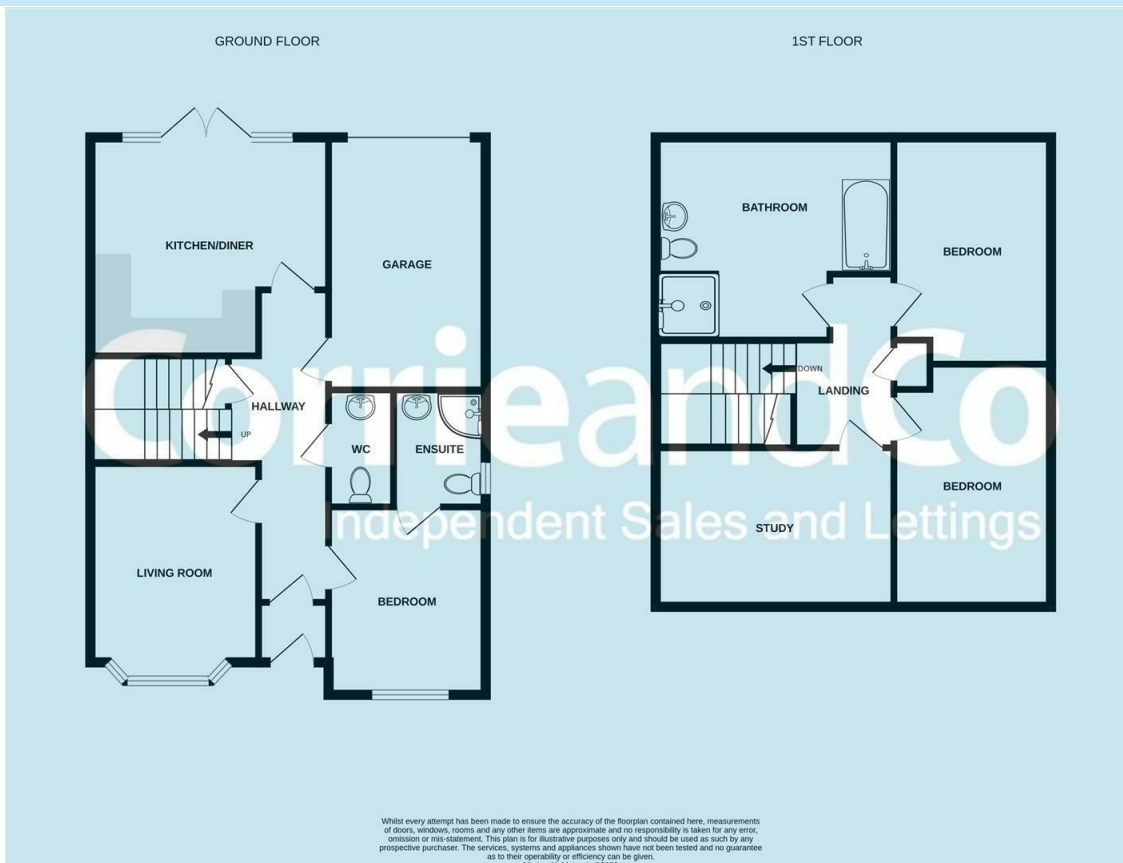
Road Map
