Corner shower cubicle, low level WC, heated towel rail, wash hand basin with mixer tap, part tiled walls.

Double glazed window to side aspect. Electric radiator, built-in wardrobe.

BATHROOM

Wash hand basin, panelled bath with shower attachment and mixer tap over, low level WC, heated towel rail, part tiled walls, extractor fan.



Bin store and communal garden.


