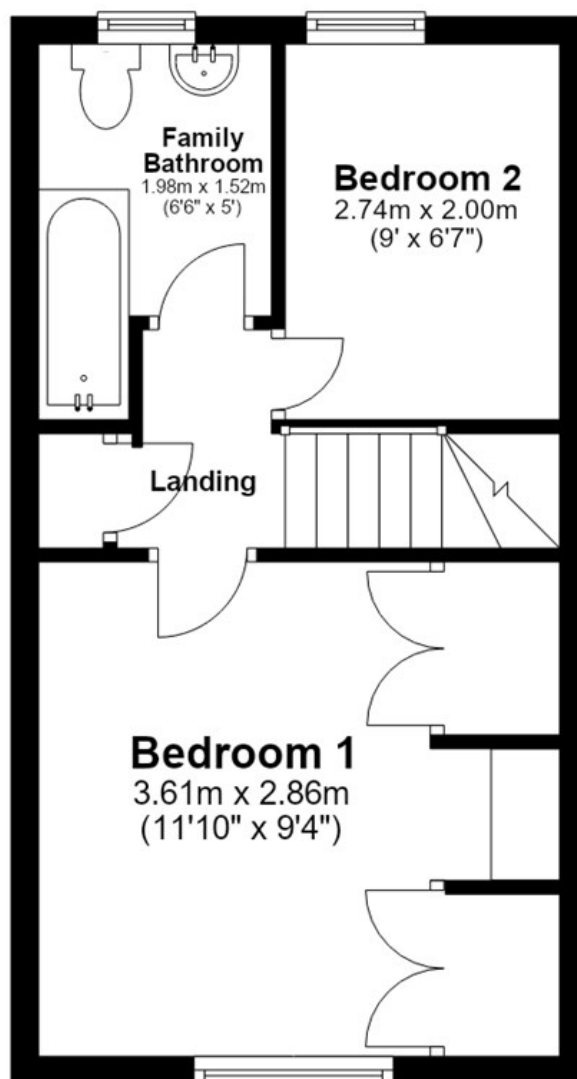
Ground Floor
