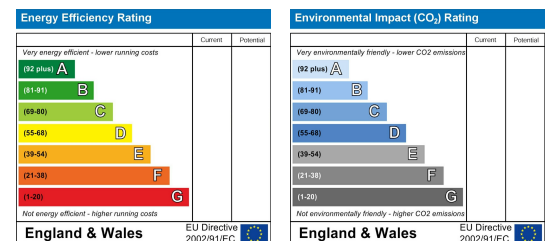
Area Map
