The property also offers potential for off road parking (subject to a dropped kerb) along with gas central heating. The accommodation briefly comprises entrance hall, cloakroom, lounge/dining room, kitchen/breakfast room, three bedrooms, bathroom, gardens to front and rear, lean-to.

Quarry tiled floor, radiator, stairs rising to first floor landing, doors to:

Comprising low flush W.C., wall mounted wash hand basin, tiled splash backs, window to side aspect, radiator.

Lounge/Dining Room

25' 3" max into bay x 11' 10" narrowing to 11' 6" (7.7m x 3.61m)

Dining Area

Single glazed bay window to front aspect, radiator, stripped wooden floorboards, picture rail, through to:

Sealed unit French doors to rear aspect, feature open fireplace, picture rail, stripped wooden floorboards, radiator.

Kitchen/Breakfast Room

21' 2" x 6' 11" max (6.45m x 2.11m) (This measurement includes area occupied by kitchen units)

Refitted to comprise ceramic butler sink with cupboard under, a range of eye level and base units providing solid wooden worksurfaces, built-in double oven, ceramic hob, extractor hood, space for fridge, sealed unit window to side aspect, door to side aspect, sealed unit French doors to rear aspect.

Sash window to front aspect, radiator.

Bathroom

Comprising low flush W.C., pedestal wash hand basin, panelled bath with shower attachment, tiled splash backs, uPVC window to side aspect, radiator.

Outside

Front - Mostly gravelled and has potential for off road parking (subject to the kerb being dropped and planning permission obtained).

Rear - Patio area, steps up to lawn with established borders stocked with a variety of plants, shrubs and trees, wooden shed, greenhouse, outside tap, enclosed by hedging and fencing and enjoys a southerly facing aspect.

Lean-To - Measures approx. 19' 9" x 5' 8" internally.
