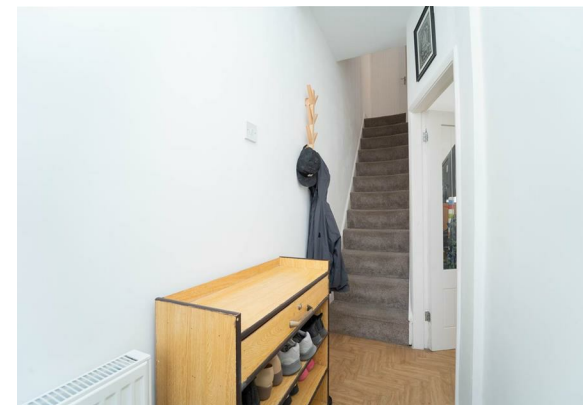

EPC Chart

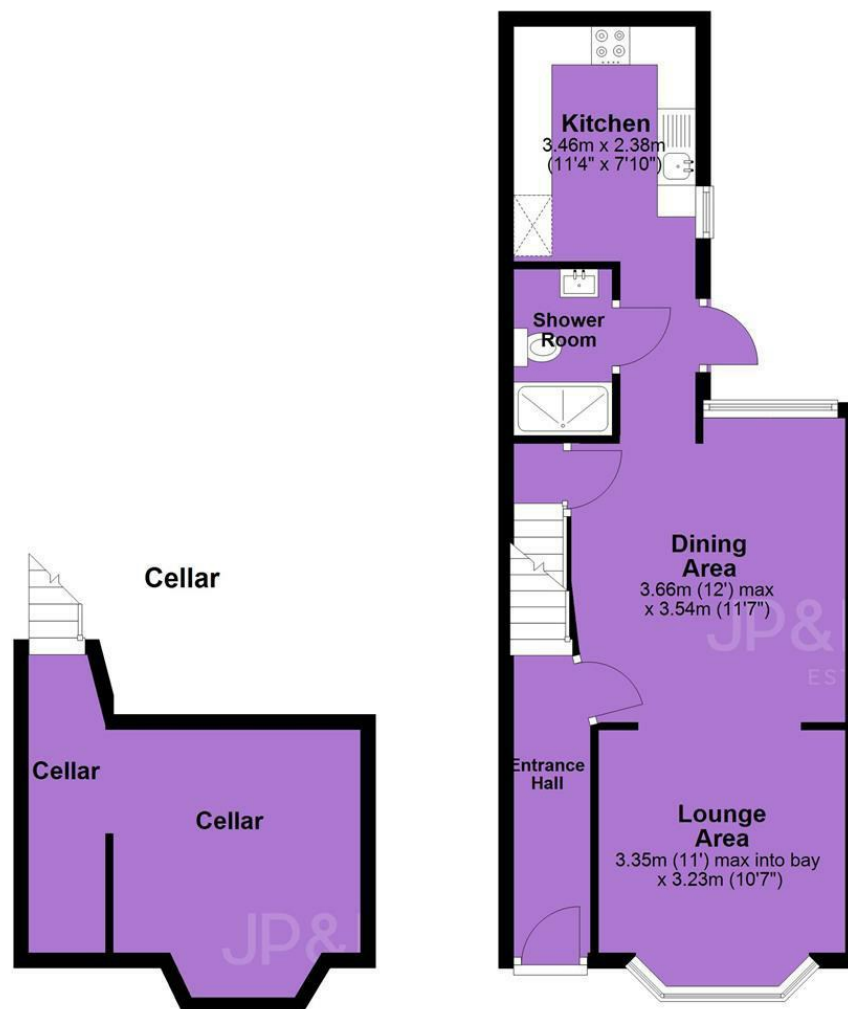
