Double-glazed window to front, two radiators, and double-glazed French doors.

Cloakroom

WC, and double-glazed window to rear.

Kitchen

Fitted kitchen with the range of wall and base cupboards, work tops, sink and drainer, electric oven, electric hob, cooker hood, tiling to the walls, radiator, double-glazed window to rear, and unders stairs cupboard.

Utility Room

Plumbing for a washing machine, double-glazed window, work tops and understairs cupboard.

Landing

Stairs from entrance hallway, loft access and double-glazed window.

Bedroom One

Double-glazed window to front and a radiator.

Bedroom Two

Double-glazed window to rear and a radiator.

Bedroom Three

Double-glazed window to front, built-in wardrobe, and a radiator.

Bathroom

Double-glazed window to rear, bath with mixer taps and a shower over, WC, wash hand basin, and tiling to the walls.

Front Garden

Lawned garden with gravel driveway and timber fencing.

Rear Garden

Lawned rear garden with concrete area leads to the garage, and timber fencing forming boundary.

Outbuilding

Garage.


