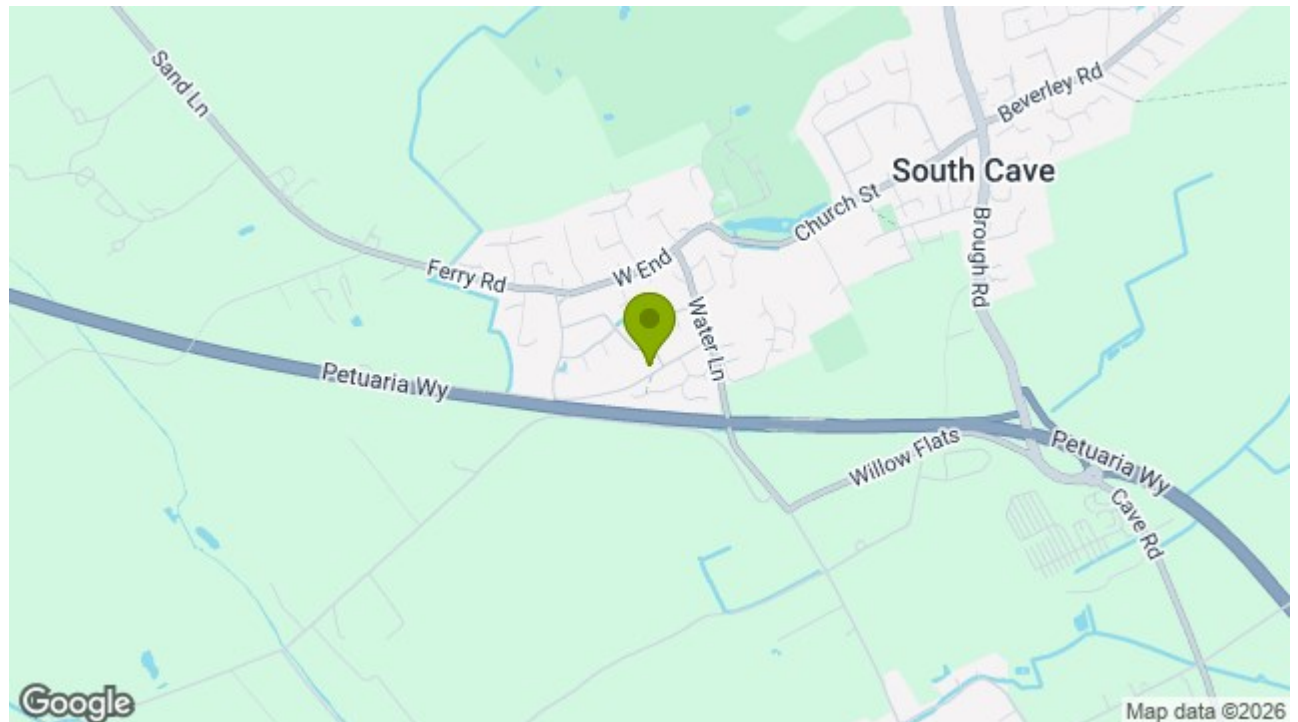

ENTRANCE HALL

Providing access to the accommodation.

LIVING ROOM

A generous living space with a wall mounted electric fire and a window to the front elevation.
