

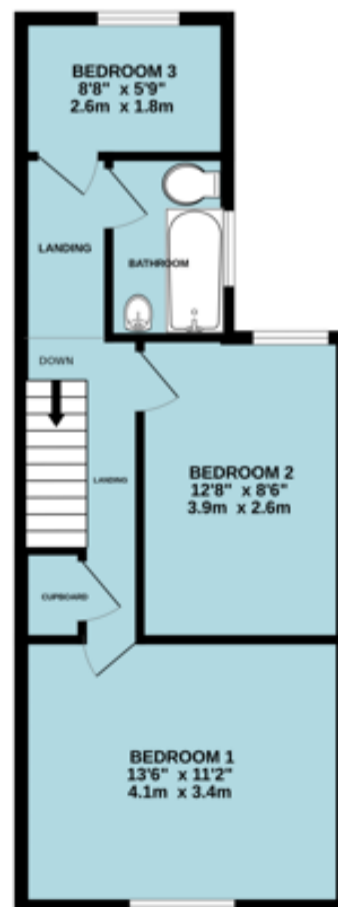

Description

Gordon Terrace is a well presented three bedroom Victorian terrace situated close to the town centre.

THE PROPERTY:

The accommodation comprises an entrance hall, sitting room with a bay window, dining room, a kitchen with a range of base and wall units and space for appliances along with a door giving access to the side of the property, a utility room and a cloakroom.

To the first floor are three double bedrooms with a family bathroom.

Outside – There is on street parking and to the rear the garden has a large patio area with a little fence opening to a lawned garden with a fence and gate opening to off-road parking to the rear.

Situated on the east side of Bridgwater with local shops and amenities close to hand and the town centre only a short walk away.
