The impressive and versatile home provides accommodation which in brief comprises: - open canopied balcony, impressive entrance hall, superb lounge with part inglenook fireplace, separate dining room/bedroom three, breakfast kitchen utility room, two large double bedrooms, the master having en-suite shower room and there is an impressive family bathroom. Outside the property enjoys grounds and gardens approached via a rear driveway and are mainly laid to lawn.

Dining Room/Bedroom Three 3.7m x 3m (12'1" x 9'10")

having Upvc double glazed window to rear elevation, one central heating radiator and coving to ceiling.

Breakfast Kitchen 3.62m x 3.67m (11'11" x 12'0")

having a good range of medium oak base and eye level units with complementary rolled edged working surfaces, sink and draining unit, integrated appliances including four ring gas hob with extractor over, dishwasher and double oven, coving to ceiling, one double central heating radiator, ceramic tiling to floor and Upvc double glazed window to rear elevation.

Utility 2.07m x 2.7m (6'10" x 8'11")

having a good range of fitted base and wall mounted units with complementary rolled edged working surfaces, stainless steel sink and draining unit, Upvc double glazed window to side elevation, ceramic tiling to floor, one central heating radiator and fitted Worcester gas fired central heating boiler.

Master Bedroom 3.63m x 5.07m (11'11" x 16'7")

having Upvc double glazed windows to front and side elevations, one central heating radiator, coving to ceiling and centre ceiling rose.

En-Suite Shower Room

having quadrant shower enclosure with fitted electric shower, pedestal wash basin, low level wc, obscure Upvc double glazed window to side elevation, fitted extractor vent and heated chrome towel radiator.

Bedroom Two 3.93m x 5.07m (12'11" x 16'7")

having Upvc double glazed windows to front and side elevations, vanity wash basin with drawers and cupboard, coving to ceiling and one central heating radiator.

Impressive Covered Front Balcony 7.25m x 1.04m (23'10" x 3'5")

having tiled floor and obscure Upvc double glazed entrance door with obscure glazed light to side opening into:

Impressive Entrance Hall

having ceramic tiling to floor, coving to ceiling, two centre ceiling roses, two central heating radiators and fitted smoke alarm.

Fabulous Sitting Room 5m x 5.3m (16'5" x 17'5")

having sealed unit double glazed arched windows to front elevation, sliding Upvc double glazed French doors overlooking the rear garden, feature rustic brick fireplace with timber mantle, quarry tiled floor and inset Living Flame gas fire, two double central heating radiators, fitted laminate flooring, centre ceiling rose, wall light points and coving to ceiling.





Bathroom

having suite comprising panelled bath, wc, wash basin, ceramic tiling to floor, coving to ceiling, obscure Upvc double glazed window to side elevation, one central heating radiator and airing cupboard incorporating lagged hot water cylinder.

Outside

The property enjoys an extremely large plot with a private driveway to the rear providing hard standing for numerous vehicles. The property stands upon a garden plot of just over 2200 sq m (approximately 0.5 of an acre), the grounds are mainly laid to lawn and to the rear of the home is a paved seating area.

Services

All mains services are believed to be connected to the property.

Measurement

Tenure


