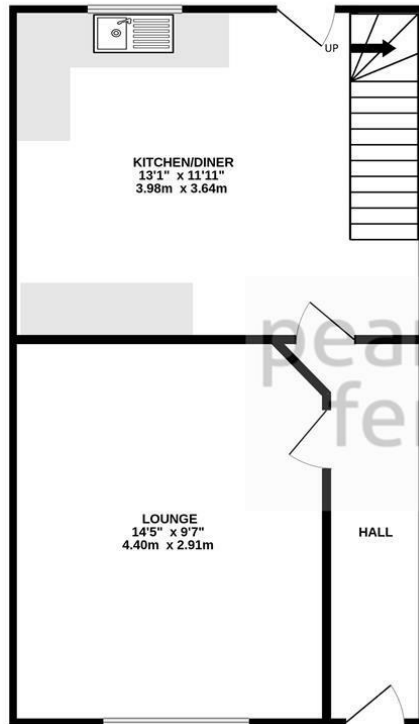

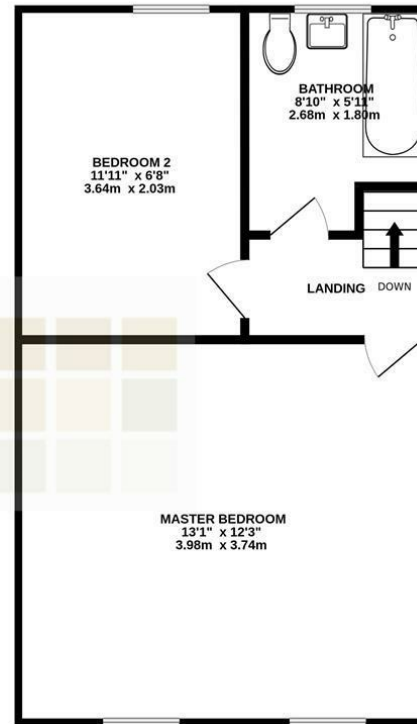




GROUND FLOOR
