Property Description

A upper floor apartment situated in the residential area of Whitley Village, close to local amenities, ideally located for the A45/A46 road networks and well placed for JLR Whitley. The accommodation briefly comprises lounge, fitted kitchen, two good sized bedrooms and a fitted bathroom. Outside there is communal parking and a garage.

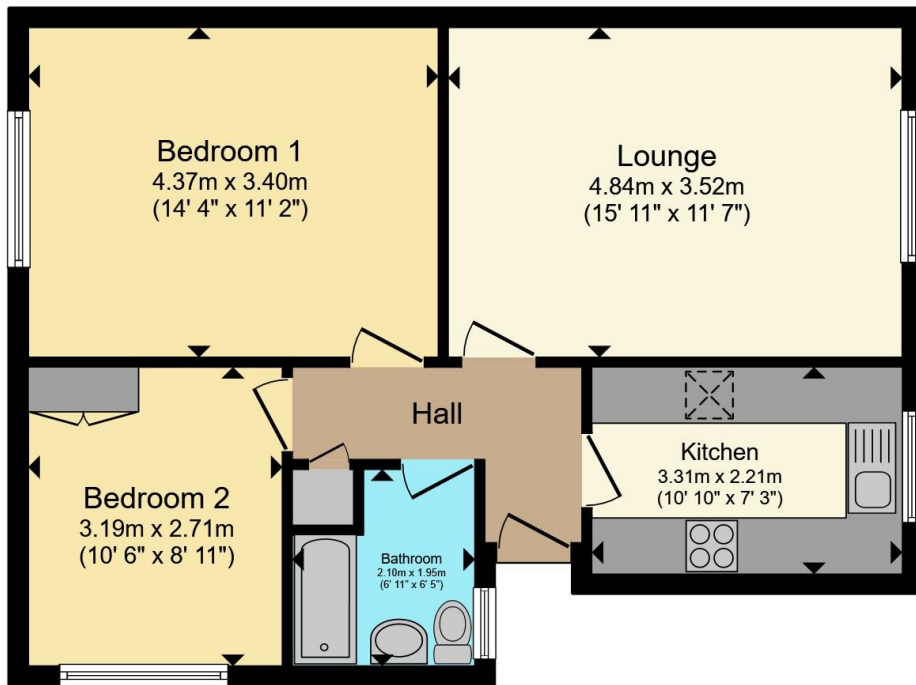

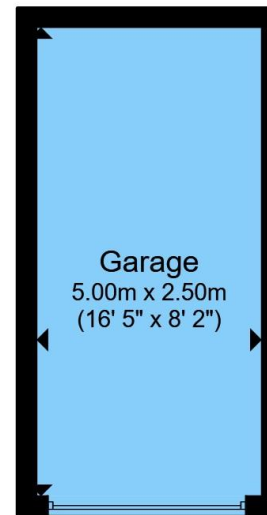
